Oxford University Staff Scholarship for the Executive MBA course at the Saïd Business School

Applications are invited from University staff to be selected for the Staff Scholarship for the 21-month Executive MBA course at the Saïd Business School, starting in January 2013. The nominee, if successful in their application to the business school, will have his or her course fees covered by his or her department's budget.
