## Council of the University

### Establishment of the degree of Master of Mathematics and Physics

#### Corrigendum

When the changes in regulations reflecting the establishment of the degree of Master of Mathematics and Physics were published on 25 April and 2 May, the word 'Philosophy' was erroneously used in place of 'Physics'.

In regulation 2.1 of Council Regulations 22 of 2002, delete both references to 'Mathematics and Philosophy, Master of Mathematics and Philosophy' and replace with references to 'Mathematics and Philosophy, Master of Mathematics and Physics'.

## Planning and Resource Allocation Committee of Council

### Changes in Regulations

The Planning and Resource Allocation Committee of Council has made the following changes in regulations, to come into effect on **14 June**.

### Establishment of the Nuffield Professorship of Population Health

#### Explanatory Note

These changes, made on the recommendation of the Medical Sciences Board, establish a new Nuffield Professorship of Population Health.

#### Text of Regulations

**1** In SCHEDULE C of Council Regulations 3 of 2004, concerning statutory professorships, after 'Rhodes Professor of Experimental Therapeutics and Clinical Pharmacology' insert:

'Nuffield Professor of Population Health'.

**2** In Sect III of Council Regulations 24 of 2002, concerning individual professorships, insert new § 262<sup>1</sup> and renumber existing §§ 262–332 as §§ 263–333:

### '§ 262. Nuffield Professorship of Population Health

1. The Nuffield Professor of Population Health shall undertake research, lecture and give instruction in population health.

2. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or if the head of the college specified in paragraph (2) below is the Vice-Chancellor, a person appointed by Council;

(2) the head of the college to which the Chair may be allocated by Council from time to time; or if the head is unable or unwilling to act, a person appointed by the governing body of that college;

(3) a person appointed by the governing body of the college;

(4), (5) two persons appointed by Council;

(6)–(9) four persons appointed by the Medical Sciences Board;

(10) a person holding a clinical appointment appointed by the relevant NHS body with which the postholder will hold an honorary contract.

3. At least three members of the board, of whom one shall be a professor, shall hold clinical appointments.

4. The professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations, which are applicable to the Chair.'

### Voting on Resolution concerning the University's Strategic Plan

¶ Members of Congregation are reminded that any two members may, not later than **noon on 3 June**, give notice in writing to the Registrar that they intend to oppose or amend the resolution below (see the note on the conduct of business in Congregation below). If no such notice has been given, and unless Council has declared otherwise or the meeting has been adjourned, the resolution shall be carried and the meeting may be cancelled.

#### Explanatory Note

The University's current Strategic Plan runs from 2008–2009 to 2012–2013. Council therefore established a steering group in Hilary term 2012, chaired by the Pro-Vice-Chancellor for Education, charged with the development of the Plan for the period 2013–2014 to 2017–2018. The group included members from Council,

the divisions and the colleges and was supported by separate groups considering in more depth the areas of research, education and widening engagement.

On 5 November 2012, Council approved a draft of the University's Strategic Plan which was circulated for comment across the collegiate University at the end of Michaelmas term 2012. Submissions on the draft plan were invited from all bodies within the collegiate University as well as individuals.

Written comments have been received from 13 individuals, 5 departments or units, 17 committees or governing bodies and 2 unions. A Congregation Discussion on the subject of the draft Strategic Plan took place on 19 February. The Strategic Plan has now been reworked in the light of comments received from the consultation. It was approved by Council on 20 May for submission to Congregation. The following summary sets out how comments received have been addressed in the final version of the Strategic Plan now being presented to Congregation.

**1** A number of comments received concerned the length and repetitive structure of the Plan. The version now before Congregation is three-quarters of the length of the previous one. This has been achieved in the main through cutting down the opening sections and removing the bullet-pointed summaries at the beginning of each set of aims. Florid expressions and long sentences have been curtailed. Repetition has been excised where possible.

**2** Throughout, reference to equality of opportunity has been expanded to include all groups with protected characteristics. References to staff development, recruitment and retention have been expanded to include more explicitly all categories of staff. A section on the size and shape of the staff body has been added, including reference to research staff. The Strategic Plan Overarching Group felt

that Personnel (paragraphs 52–61) should remain a 'Core Strategy', reflecting the acknowledgement that the strength of the University's activities is dependent on the ability to recruit and retain the highest calibre staff.

**3** The section on Widening Engagement (paragraphs 41–51) has been reworked to make the University's commitment to innovation and enterprise and interaction with business and industry more explicit. Commitments to working with healthcare partners have also been more clearly delineated. At the same time, emphasis on the value Oxford places on strong core disciplines has been strengthened (inter alia, paragraph 22).

**4** The section on size and shape of the student body (paragraph 37) has been amended to provide greater clarity on intentions in this regard and to make reference to the review currently taking place. The need to provide adequate financial support for students has been added to the introduction as well as the 'Education' section (paragraphs 3 and 27). The section on individualised student support has been strengthened (paragraph 29).

**5** Greater prominence and clarity has been given to the commitment to an enhanced online presence and to the development of a digital strategy for the University (paragraphs 9, 45, 46, 75).

**6** The intention to ensure efficiency through more effective monitoring of costs and budgets is noted, including a commitment to the ongoing review of administrative services (paragraph 63).

**7** The section on Development (paragraphs 76–78) has been expanded. It now also includes reference to alumni relations in addition to those references which appear throughout the Plan.

Oxford shares with Cambridge the distinction of a Council that is responsible to Congregation, and to its members. Congregation has provided democratic procedures to come to decisions on complex problems. Most recently, members of the University have had occasion to be concerned with high profile developments, such as the building of student accommodation blocks near Port Meadow or the re-design of the Radcliffe Observatory Quarter, both of which have generated considerable and controversial discussions.

Over the past decade, the University has enjoyed a period of remarkable growth - in student numbers, income and estate. Even if it were thought desirable, it is unlikely that continued growth at this rate could be sustained. In the next few years, we need to manage the move to a more steady state. We shall need to balance competing claims on limited resources.

Different pressures are faced by different divisions and each has developed its own strategies to tackle these. Many perceive the establishment of divisions as a success, but this structure brings its own problems, both within and between divisions. Further effort is needed to facilitate teaching and research across divisional boundaries.

Oxford undergraduates continue to benefit from an excellent education, but the experience of their postgraduate colleagues is more mixed. There is scope for improvement of what is offered at postgraduate level, particularly in taught courses. Colleges should continue to have a central role in the work of the University. The growth in the number of postgraduates has generated further pressures on the colleges in terms of funding and accommodation. These considerations will be important in discussions on the future size and shape of the University.

As Senior Proctor in 2012/13, I have gained some understanding of the workings of Council and all of its major committees. I am a medical geneticist. I have been Fellow and Tutor in Medicine at St Peter's College since 1991 and Deputy Director of the University's graduate entry medical course since 2009.

The Bodleian, and the two components of it with which I became most familiar during my career here (the Radcliffe Science Library and the Cairns Library), are extraordinary libraries by any and all standards. I'm particularly keen to bring a user-centred view and a push to the further development of its digital infrastructure. I have read in the recent Curators' published minutes the summary of the 2012 Bodleian Reader Survey conducted by the LibQual-Lite instrument. It flagged up "*Making electronic resources accessible from my home or office*" to be in the Red band where perceived current levels of service fall below the minimum expected. As a critical friend I want to do my bit to help improve this.

I teach politics at Harris Manchester and also do some teaching for the History and Theology faculties; my research is in the area of medieval intellectual history. I am also Senior Tutor of my college.

The interdisciplinary nature of my work takes me to various parts of the Bodleian Libraries, but my research is highly dependent on their collections of unique manuscripts and early printed books. The Bodleian's Special Collections are my equivalent of a laboratory: without them, I could not do my work.

I see myself as a critical friend of the Library. Money is tight, and in that context it's inevitable that there are hard choices to be made. In some subjects, electronic provision to the desktop may be the only way forward; in others, packed reading rooms show the continuing central role of well-organized subject provision and library work space, in conjunction with digital materials. Knowledgeable, accessible staff remain irreplaceable.

Major developments, including the opening of the Weston Library, the reconsideration of the ROQ and the advent of electronic legal deposit make this a critical period in the history of the Bodleian. That is why I believe ordinary users need to take a constructive role in the oversight of the Libraries.
