Admission of Proctors and Assessor

Congregation 19 March

(1) Voting on a Resolution authorising a site allocation including 1–6 Winchester Road for occupation by Reuben College

Explanatory Note

These six residential properties were allocated to Reuben College in summer 2023 under a Heads of Terms agreement to facilitate their handover for the current academic year, pending the details of a longer term allocation being agreed. Nos 3, 4, 5 and 6 Winchester Road had previously formed part of the professorial stock, No 2 had been let to St Anne’s College (now vacated) and No 1 is subject to a private letting. Nos 1 and 2 will require substantial refurbishment/structural works by Reuben College. The allocations will support the college’s commitment to increase student numbers.

Text of Resolution

That the site comprising approximately 2,138 sqm encompassing the properties at 1–6 Winchester Road and their land and (subject to the take back provisions detailed in the Heads of Terms) gardens be allocated to Reuben College for a term of 21 years from 1 August 2024 for use/conversion as additional graduate accommodation, noting that vacant possession is subject where appropriate to the University seeking to bring their current usage to an end within the terms of the relevant occupational tenancies.

(2) Voting on a Resolution authorising a site allocation including nos 49 and 55 Banbury Road, for occupation by Kellogg College*Explanatory Note*

This site comprises four separate mixed-use properties. Nos 49 and 55 Banbury Road were allocated to Kellogg College in summer 2023 under a Head of Terms agreement to facilitate their handover for the current academic year, pending the details of a longer-term allocation being agreed. No 49 had been privately let and No 55 had been part of Graduate Accommodation. No 47 remains occupied by the Faculty of History until their decant to the newly constructed Schwarzman Centre (anticipated MT 2025). Nos 51–53 are occupied by the School of Anthropology and Museum Ethnography (SAME) who will decant to Le Gros Clerk following its refurbishment (anticipated MT 2026). These latter properties will require refurbishment and conversion to facilitate graduate use. The allocations will support the college's commitment to increase student numbers.

Text of Resolution

That the site comprising approximately 2,299 sqm encompassing the properties at 47–55 Banbury Road and their land and (subject to the take back provisions detailed in the Heads of Terms) gardens be allocated to Kellogg College for a term of 21 years from either 1 August 2024 or the date of handover to be agreed, whichever is the later as the case may be, for use/conversion as additional graduate accommodation, subject where appropriate to the University seeking to bring their current functional usage to an end and, in respect of 49 and 55 Banbury Road, subject to the college not seeking vacant possession of 64 Banbury Road until the Le Gros Clark Building project is complete and SAME are able to decant to the new facility.

(3) Voting on a Resolution authorising a site allocation including nos 2, 4 and 6 Bradmore Road, for occupation by Kellogg College*Explanatory Note*

No 2 is currently part of the Graduate Accommodation portfolio; Nos 4 and 6 are both professorial stock. The new allocation of these properties will support the college's planned increase in student numbers and the consolidation of a college campus in this vicinity.

Text of Resolution

That the site comprising approximately 1,493 sqm encompassing the properties at 2, 4 and 6 Bradmore Road and their land and gardens be allocated to Kellogg College for a term of 21 years from 1 August 2024 for use/conversion as additional graduate accommodation, subject to the college not seeking vacant possession of 64 Banbury Road until the Le Gros Clark Building project is complete and SAME are able to decant to the new facility, and the college making good any net loss in residential/graduate portfolio surplus for the period 2023/24 to 2025/26.

(4) Voting on a Resolution authorising a site allocation including 8 Bradmore Road for occupation by Kellogg College*Explanatory Note*

No 8 Bradmore Road is already occupied by Kellogg under a Heads of Terms agreement expiring in August 2047. This allocation approval is sought retrospectively to regularise the existing use and to support the college's commitment to increase student numbers.

Text of Resolution

That the site comprising approximately 859 sqm comprising 8 Bradmore Road and its land and gardens, be allocated to Kellogg College for a term from 1 May 2018 to 31 August 2047 for use/conversion as additional graduate accommodation, subject to the college not seeking vacant possession of 64 Banbury Road until the Le Gros Clark Building project is complete and SAME are able to decant to the new facility, and the college making good any net loss in residential/graduate portfolio surplus for the period 2023/24 to 2025/26.

(5) Voting on a Resolution authorising a site allocation including 9/10 and 11 Bradmore Road for occupation by Kellogg College

Explanatory Note

Both Nos 9/10 and 11 Bradmore Road are allocated to Kellogg until 2026 (under a Heads of Terms agreement). The proposal extends the allocations by a further 18

years to support the college's commitment to increase student numbers and the consolidation of a college campus in this vicinity.

Text of Resolution

That the site comprising approximately 3,000 sqm encompassing the properties at 9/10 and 11 Bradmore Road and their land and gardens be further allocated to Kellogg College for a term of 21 years from 1 August 2023 for use as graduate accommodation, subject to the

college not seeking vacant possession of 64 Banbury Road until the Le Gros Clark Building project is complete and SAME are able to decant to the new facility and the college making good any net loss in residential/graduate portfolio surplus for the period 2023/24 to 2025/26.

(6) Voting on a Resolution authorising a site allocation including 58/58a Banbury Road for occupation by Kellogg College

Explanatory Note

An agreement was reached in 2018 that 58 and 58A Banbury Road would be allocated to Kellogg following the relocation of the occupying department SAME, in return for which Kellogg would permit SAME to continue occupying its property at 64 Banbury Road. SAME will vacate both properties following the refurbishment of Le Gros Clerk, anticipated MT 2026. 58 and 58A Banbury Road are located adjacent to Kellogg's main college buildings and therefore will allow the college to expand and consolidate in this location. The exact use of 58 and 58A by Kellogg, whether for accommodation or otherwise, is to be agreed prior to handover.

Text of Resolution

That the site comprising approximately 1,195 sqm encompassing the properties and land at 58 and 58A Banbury Road be allocated to Kellogg College for a term of 30 years from the date of handover (to be agreed), subject to the University seeking to bring their current functional usage to an end, and to the college's agreement to the renewal of the 10 year leaseback of 64 Banbury Road from 2018 permitting SAME to continue to occupy the property until they decant to a new facility (currently anticipated MT 2026).

Ashmolean Museum

REQUEST FROM THE HIGH COMMISSION OF INDIA FOR THE RETURN OF TWO INDIAN BRONZES HELD BY THE ASHMOLEAN MUSEUM

In accordance with the procedure for dealing with repatriation claims set out in the University's Procedures for Claims for the Return of Cultural Objects, the Visitors of the Ashmolean Museum have considered the request for the return of two Indian Bronzes from the High Commission of India: a 16th-century bronze of Saint Tirumankai Alvar (EA1967.42) and an 11th-century bronze Siva with Attendants (LI181.16). Having considered the evidence relating to both claims the Visitors are recommending that Council agree to the return of EA1967.42 to the temple of Shri Soundarraja Perumal Kovil in Kumbakonam, Tamil Nadu, India, on moral grounds; and that Council do not agree to the return of LI181.16 as there is no evidence to support

the work's previous ownership or its possible theft. The Procedures for Claims for the Return of Cultural Objects (www.glam.ox.ac.uk/procedures-for-return-of-cultural-objects-claims), requires that, when the governing body of the relevant museum has submitted a claim to Council, notice of the recommendation and availability of the dossier of the case for consultation should be advertised in the *Gazette*, giving parties with an interest an opportunity to comment. Any comments received are to be considered by Council in reaching a final decision on the recommendation submitted by the Board of Visitors of the Museum.
