# **Council and Main Committees**

## **Council of the University**

### **Changes to Regulations**

Council has made the following changes to regulations, to come into effect on **31 May** unless notice of a resolution calling upon Council to annul or amend

the regulation is received by the Registrar by **noon on 27 May** (as set out in Statute VI: Council).

## (a) Regulations for the Employment of University Staff

## **Explanatory Note**

The following changes have been made, at the request of the Humanities, Mathematical, Physical and Life Sciences, and Medical Sciences Divisions and Continuing Education and Gardens, Libraries and Museums to enable the title of Professor of Practice to be used in appropriate cases in all those areas, including for staff on grades 9 and 10.

#### Text of Regulations

In <u>Council Regulations 3 of 2004</u>, concerning the employment of University staff, amend as follows (new text underlined, deleted text struck through):

'Regulations for the Employment of University Staff

9. The following persons shall be eligible to apply for the title of professor of practice:

(1) all those in the grades 9, 10 and of RS IV in the Social Sciences Division; and

(2) all those in the grade of associate professor in the Social Sciences Division.'

## (b) Regulations for the Student Fitness to Study Panel

## Explanatory Note

The following changes have been made to align with a restructure of the subcommittees of Education Committee that came into force on 5 May 2023, which disbanded the Student Wellbeing Subcommittee of the Education Committee and the Joint Subcommittee of the Education Committee with Student Numbers, and established the Student Life Subcommittee of the Education Committee to oversee extra-curricular and non-academic student matters.

## Text of Regulations

In <u>Council Regulations 1 of 2012</u>, concerning Regulations for the Student Fitness to Study Panel, amend Part 6: Annual Report, as follows (new text underlined, deleted text struck through):

'Regulations for the Student Fitness to Study Panel

Part 6: Annual Report

6.1. The Panel shall provide an annual report on its activities, making recommendations as appropriate, to the Student WellbeingLife Subcommittee of the Education Committee.'

## (c) Regulations for Committees Reporting Directly to Council or one of its Main Committees: Education Committee (i)

## **Explanatory Note**

The following changes have been made to reflect a change in membership following amendments to the name of one panel reporting to the Education Committee and a restructure of the subcommittees of the Education Committee that came into force on 5 May 2023, and also to remove gendered language.

## Text of Regulations

In <u>Part 2 of Council Regulations 15 of 2002</u>, concerning the Education Committee, amend as follows (new text underlined, deleted text struck through):

'Regulations for Committees Reporting Directly to Council or one of its Main Committees

2.1 The Education Committee shall consist of:

...

(13) the Chair of the Taught Degrees <u>and Awards</u> Panel;

(16) the Chair of the Student Wellbeing Subcommittee the Chair of the Student Life Subcommittee;

•••

2.4

...

(3) Decisions on applications will be made on behalf of Education Committee by the Pro-Vice-Chancellor (Education) or his or hertheir nominee.

(4) An applicant who is dissatisfied with a decision made on behalf of Education Committee, may, or hisor hertheir college or department may, appeal against it. An appeal must be made within fourteen days of the date of Education Committee's decision. Any such appeal must be made in writing. The appeal will be heard by two members of Education Committee with no previous connection to the case.'

## (d) Regulations for Committees Reporting Directly to Council or one of its Main Committees: Education Committee (ii)

#### Explanatory Note

The following changes have been made to formalise the Graduate Admissions Committee as a subcommittee of Education Committee and to establish a new subcommittee of Education Committee to provide direction for University-led activities which support people with displacement backgrounds.

### Text of Regulations

In <u>Council Regulations 15 of 2002</u>, concerning Other committees, add Parts 40 and 41 as follows:

## Part 40: Graduate Admissions Committee: Subcommittee of the Education Committee

- 40.1 The Graduate Admissions Committee shall consist of:
  - (1) the Pro-Vice-Chancellor (Education), or their nominated deputy, who shall chair the Committee;
  - (2)–(5) the Associate Head of Education or their nominee from each Division:
  - (6) the Associate Head of Education or their nominee from the Department for Continuing Education;
  - (7) the Chair of the Graduate Committee of the Conference of Colleges or their nominee;
  - (8) a Head of House elected by the Conference of Colleges;
  - (9) a Tutor for Graduates elected by the Conference of Colleges;
  - (10) a Bursar or Domestic Bursar elected by the Conference of Colleges;
  - (11) one of the sabbatical trustees of Oxford University Student Union as may be agreed between them;
  - (12) the Director of Graduate Admissions and Recruitment;

- (13) the Director of Student Fees and Funding;
- (14) the Head of Residential Accommodation;
- (15) a representative from Education Policy Support.
- 40.2 With the approval of the Education Committee on each occasion, the Subcommittee may co-opt up to two additional members.
- 40.3 Elected, appointed or co-opted members shall hold office for a period of three years and shall be eligible to serve for a total period of six years.
- 40.4 The Graduate Admissions Committee shall be responsible to Education Committee for:
  - (1) steering strategic change to bring transformative developments in graduate admissions;
  - (2) championing the applicant experience;
  - (3) owning the end-to-end graduate admissions process, including oversight of graduate accommodation, setting a vision for the overall process in accordance with the University's Strategic plan, and monitoring and evaluating progress against the targets set in the Plan;
  - (4) establishing the roadmap to the One Offer vision, agreeing key data and improvement targets, and establishing the appropriate activities required to make progress;
  - (5) advocating and supporting all opportunities for streamlining and improving the current overall process;
  - (6) raising the profile of the graduate admissions process internally in light of the increasing significance of graduate applicants in overall student numbers.

40.5 The subcommittee will make an annual report to Council via Education Committee on the work of the Subcommittee.

40.6 The subcommittee shall meet at least twice per year.

## Part 41: The University of Sanctuary Steering Committee: Subcommittee of Education Committee

- 41.1. The University of Sanctuary Steering Committee shall consist of:
  - (1) a chair appointed by the Vice-Chancellor on the recommendation of Education Committee;
  - (2) a representative of the University's Refugee Studies Centre:
  - (3) a representative from Colleges with College of Sanctuary Status;
  - (4) the Head of Student Fees and Funding, or their nominee:
  - (5) one of the sabbatical trustees of Oxford University Student Union as may be agreed between them;
  - (6) a representative from Oxford University Development Office;
  - (7) a person elected by the Conference of Colleges;
  - (8)–(11) four persons elected by the Divisions;
  - (12) a representative of City of Sanctuary;
  - (13) the University's designated coordinator for Oxford Sanctuary Community (or equivalent);
  - (14) a student representative current student with lived experience of forced displacement;
  - (15–16) up to two external members with relevant expertise.

- 41.2. Other members of the University will be invited to attend meetings for relevant agenda items.
- 41.3. With the approval of the Education Committee on each occasion, the subcommittee may co-opt up to two additional members
- 41.4. Elected, appointed or co-opted members shall hold office for a period of three years and shall be eligible to serve for a total period of six years.
- 41.5. The University of Sanctuary Steering Committee shall be a subcommittee of Education Committee and shall be responsible to Education Committee for the oversight and strategic direction of University activities which support people with displacement backgrounds.
- 41.6. In the exercise of its responsibilities the Steering Committee shall:
  - (a) provide strategic direction for University-led activities which support people with displacement backgrounds;
  - (b) monitor progress in achieving the actions identified in the institutional University of Sanctuary Award;
  - (c) oversee new and existing University scholarship schemes which support people with displacement backgrounds;
  - (d) oversee renewal applications for the University of Sanctuary Award;
  - (e) review, assess, and award College of Sanctuary status to individual Oxford colleges and private halls based on clearly defined criteria;
  - (f) make an annual report to Council via Education Committee on the work of the subcommittee.
- 41.7. The subcommittee shall meet at least twice per year.'

## (e) Regulations for the Committee for the Ruskin School of Art

#### Explanatory Note

The following changes have been made to ensure that the Head of the Ruskin School of Art chairs the Committee for the Ruskin School of Art.

#### Text of Regulations

In <u>Council Regulations 2 of 2004</u>, concerning Regulations for other University Bodies, amend the section concerning the Committee for the Ruskin School of Art as follows (new text underlined, deleted text struck through):

- '7.1. There shall be a Committee for the Ruskin School of Art consisting of:
  - (1), (2) two persons appointed by the Humanities Board, one of whom shall chair the committee;

(1) the Head of the Ruskin School of Art, who shall chair the committee;

(2) one person appointed by the Humanities Board;

(3)–(14)(13) up to twelve persons holding the post of Professor or Associate Professor in the Ruskin School of Art:

(15) (14) a person appointed by the Committee of Senior Tutors.'

# (f) Regulations for the Strategic Capital Steering Group and the Planning and Housing Strategy Group

**Explanatory Note** 

The Strategic Capital Steering Group (SCSG) and the Planning and Housing Strategy Group (PHSG) are to be merged for reasons of efficiency. It is proposed that the regulations for PHSG be discontinued and the regulations for SCSG be amended to reflect the merger.

### Text of Regulations

In <u>Part 12 of Council Regulations 15 of 2002</u>, concerning the Strategic Capital Steering Group, amend section 12.2 of the existing regulations as follows (new text underlined, deleted text struck through).

Subject to approval of these changes, discontinue <u>Part</u> 35 of Council Regulations 15 of 2002, concerning the Planning and Housing Strategy Group.

- '12.2. The Strategic Capital Steering Group shall:
  - (1) develop a long-term strategic capital investment plan for submission to the Finance Committee;
  - (2) consider the use of any capital resources which are not delegated or allocated to the academic divisions, services, or other bodies (whether trust funds, University reserves, unearmarked benefactions, capital funds or reserves of any other description), and recommend to the Finance Committee major new initiatives regarding such use;
  - (3) in accordance with the allocation limits set out in Statute XVI and the Financial Regulations:
    - (i) submit recommendations to the Finance Committee for expenditure on strategic investments in the University's physical estate, and other academic resources (other than centrally run IT projects) and any associated space allocations that require the approval of Council;
    - (ii) approve expenditure on developing proposals for strategic investments in the University's physical estate and other academic resources (other than centrally run IT projects) that does not require the approval of Council;
  - (4) liaise with PRAC to ensure that the proposals for strategic capital investment are compatible with the rolling capital programme; three-year settlement and long-term use of resources;

- (5) ensure that business cases for projects being considered by the Group have been appropriately prepared, signed by the appropriate officers of the University in accordance with the Financial Regulations and are consistent with the University's priorities and plans; and
- (6) oversee the financial management of the design of projects submitted in accordance with these regulations, including the gateway approval process, and obtain approval from the Finance Committee for expenditure on gateways 1 and 2 prior to that committee's release of full project funding.
- (7) establish and oversee programme boards with responsibility for the development of specific sites for the functional estate; advise Finance Committee and Council on all aspects of University staff and student housing development, including the promotion of land through the planning system for staff or student housing developments and for research and innovation development, including:
  - (i) identifying functional estate projects, staff or student housing projects and innovation space proposals that should be submitted to Oxford University Property Development (OUPD) for consideration;
  - (ii) consider development proposals for staff or student housing and innovation space put forward by Oxford University Property Development (OUPD);
  - (iii) the purchase of additional land for development;
- (8) establish and oversee programme boards with responsibility for the development of specific sites for all specific strategic developments.
- (8) make recommendations to Finance Committeewith regard to:
  - (i) proposed functional estate projects that should be submitted to Oxford University Property Development (OUPD) for consideration;
  - (ii) development proposals for the functional estate put forward by OUPD;
  - (ii) the purchase of additional land for development.'

## (g) Regulations for Convocation Elections

## **Explanatory Note**

These changes reflect feedback from members of the University, and are there to better clarify the original intended role of the Chancellor's Election Committee, to provide further transparency over the process as well as the exclusion criteria, for the benefit of this and future elections. The process will be conducted in accordance with all legal obligations, including the Public Sector Equality Duty, but Council has agreed that this need not be made explicit.

#### Text of Regulations

In <u>Council Regulations 8 of 2002</u>, concerning Convocation elections, amend as follows (new text underlined, deleted text struck through).

'Regulations for Convocation Elections

1. An election in Convocation shall be held in Full Term, unless Council shall order otherwise, on a date fixed by Council.

#### **Election of the Chancellor**

- 2. The election to fill a vacancy shall take place as soon as may be after the occurrence announcement of the vacancy (subject to the provisions of regulation 1 above).
- 3. The Chancellor shall be elected in accordance with the following procedure:
  - (1) The Chancellor's Election Committee shall oversee organise the election process, and shall play no substantive role in the selection of a Chancellor.
  - (2) The committee shall consist of:
    - (a) the High Steward, who shall chair the committee;
    - (b) the Vice-Chancellor, who shall be deputy chair of the committee;
    - (c) one person appointed by Council from among current external members of Council;
    - (d) two members of Council appointed by Council from among the members of Council specified in section 4 (16)–(26) of Statute VI;
    - (e) one member of Congregation to be appointed by the Gardens, Libraries and Museums, University Administrative Services and the Department for Continuing Education:
    - (f)–(i) one member of Congregation appointed by each of the divisional boards;

- (j) the early career research staff representative who attends Council;
- (k) the Chair of the Conference of Colleges;
- (3) The committee may co-opt up to two additional members for such periods as the committee shall deem appropriate.
- (4) The committee shall report to Council as necessary.
- (5) The committee shall be responsible for:
  - (a) determining establishing the timeline for the election process, including the date by which applications must be received and the date of the election;
  - (b) approving advertising the role specification for the post and determining establishing the information to be provided by candidates;
  - (c) recommending to Council the term of office for each new Chancellor election.
- (6) The date of the election is the day the poll closes, after which time it is no longer possible to cast a vote: and not the date the results are announced.
- (7) The exclusion criteria for the role of Chancellor shall be as follows, with all applying from the point of taking up the post:
  - (a) the Chancellor cannot be a student of the University;
  - (b) the Chancellor cannot be an employee of the University;
  - (c) the Chancellor cannot be a serving member of, or a declared candidate for election to, an elected legislature;
  - (d) the Chancellor must not be disqualified from being a charity trustee by virtue of section 178 of the Charities Act 2011 (or any statutory re-enactment or modification of that provision) or subject to a disqualification order made by the Charity Commission and must be a "fit and proper person" as determined by guidance published from time to time by His Majesty's Revenue & Customs.
- (7)(8) After the closing date for applications, the committee shall consider all those it has received, and, having due regard to the exclusion criteria onlyprinciples of equality and diversity and the approved role specification, shall determine which candidates are eligible to progress put forward those

<u>candidates not excluded under the terms of (7)</u> to the next stage of the election process.

(8)(9) If the committee determines that only one candidate will is eligible to progress to the next stage of the selection election process or if only one candidate remains after other candidates have withdrawn, Council will be required to determine whether that candidate shall be deemed to be duly elected and the result published in the University Gazette or if further applications should be sought to allow an election to be held Convocation will be asked to elect or reject such candidate via a "yes", "no" vote by a simple majority. In the event of a "no" vote the application process will be reopened by the committee and a second election arranged.

(9)(10) If the committee determines that no candidate is eligible to progress to the next stage of the selection election process, or all have withdrawn, Council shall invite further applications to allow an election to be held.

(10)(11) If the committee determines that more than one candidate is eligible towill progress to the next stage of the selection election process, an election by Convocation shall be held as follows:

(a) Voting shall be online.

(b) The electoral system shall be decided recommended by the Chancellor's Election Committee to Council and published prior to the application process commencing.

(c) The Registrar shall be responsible for the counting of the votes but the Vice-Chancellor and Proctors shall decide on the validity of any vote which, in the opinion of the Registrar, is in doubt.

(d) In the case of an equality of votes, the Chair of the Chancellor's Election Committee shall decide between the candidates.

(e)(d) The result of the election shall be published in the University *Gazette*.'

## Congregation 11 June

## (1) Voting on a Legislative Proposal: Statute XVI Property, Contracts and Trusts

#### **Explanatory Note**

The following changes have been made to incorporate 'rights retention' on an opt-out basis in line with the University of Oxford's preference for the 'green' or self-archiving route to open access.

#### Legislative Proposal

WHEREAS it is expedient to make changes to the arrangements for non-academic student discipline, THE UNIVERSITY ENACTS AS FOLLOWS.

In <u>Part B of Statute XVI</u>, concerning Property, Contracts and Trusts, insert a new section 9 as follows and renumber following sections accordingly:

#### **Intellectual property**

9. (1) The University operates an Open Access Publications Policy which promotes making peerreviewed research outputs available on an open access basis to increase their availability and use by others. Pursuant to the Open Access Publications Policy, those persons covered by the circumstances in section[s] 5 (1) (a)[, (c) and (d)] automatically and

in advance grant to the University a non-exclusive, irrevocable, worldwide, sublicensable licence of the copyright which they own in certain peer-reviewed research outputs, to make those outputs publicly available under the terms of a Creative Commons Attribution (CC BY) licence, or alternative licence terms if requested, provided that such licence complies with any applicable funder requirements. The peer-reviewed research outputs licensed by those persons to the University are: articles, reviews and conference papers, which are accepted for final publication in a journal, conference proceeding or publishing platform.

- (2) Those persons to whom section 9 (1) applies shall, upon request by the University, take any steps and/or sign any documents necessary in order to give effect to the licence set out in Section 9 (1).
- (3) Sections 9 (1) and 9 (2) of this statute do not apply to student members of the University, even if the criteria set out in section 5 (3) of this statute are met, and/or if any of the circumstances set out in sections 5 (1) (a), (c) or (d) apply to student members.'

## (2) Voting on a Resolution authorising the allocation of space in Warneford Wellcome and Warneford Main to the Department of Psychiatry

## **Explanatory Note**

The Department of Psychiatry occupies several Oxford University Hospitals NHS Foundation Trust-owned buildings at the Warneford Hospital site, including Warneford Wellcome and Warneford Main. In December 2023 the University formalised its long-standing occupation of this space to provide certainty and protect the University's ongoing occupation. The proposed space allocations seek to formalise the Department of Psychiatry's occupations in line with the University's internal space allocation governance procedures.

## Text of Resolution

That approximately 776 sq m NUA within Warneford Wellcome (building number 644) be allocated to the Department of Psychiatry for a period of approximately 70 years, from 20 December 2024 until 19 September 2093.

That approximately 695 sq m NUA within Warneford Main (building number 645) be allocated to the Department of Psychiatry for a period of approximately 55 years, from 20 December 2024 until 23 March 2079.

# (3) Voting on a Resolution authorising the allocation of space in K Wing at Oxford University Press to the Finance Division

### **Explanatory Note**

The University intends to surrender early its leases at Beaver House, in order to avoid rent increases, and realise other financial benefits. It is proposed to use Oxford University Press as decant space for the Finance Division, who are currently housed on the ground floor of Beaver House. The move to OUP will deliver significant space efficiencies aligned with the objectives of the UAS space review through the implementation of New Ways of Working.

#### Text of Resolution

That approximately 706 sq m within K Wing, Oxford University Press, Great Clarendon Street, be allocated to the Finance Division for an initial period of approximately three years from 16 September 2024.

In accordance with the procedure for dealing with repatriation claims set out in the University's Human Remains Policy and Procedures for the return of Human Remains, the Board of Visitors of the History of Science Museum has considered a claim from the Karanga Aotearoa Repatriation Programme of New Zealand for the repatriation of two skulls (INV10115). These skulls formed part of a series of experiments on trephination by T Wilson Perry in the early 20th century. The Visitors are recommending that the Council agree to the return of both skulls.
