Voting on Legislative Proposal: Schedule to the Council Statutes Part 48: Associate Professor in Transport Studies; Part 65: Jesus Professorship of Celtic Endowment Fund; Part 67: Goodger and Schorstein Fund for Research Scholarships in Medical Science; Part 69: Scatcherd Scholarships

Explanatory Note

The following legislative proposal amends four parts of the Schedule to the Council Statutes to reflect the accession of King Charles III.

WHEREAS it is expedient to change the existing provisions governing the Associate Professor in Transport Studies, Jesus Professorship of Celtic Endowment Fund, Goodger and Schorstein Fund for Research Scholarships in Medical Science and Scatcherd Scholarships, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of His Majesty in Council, AS FOLLOWS.

In the Schedule to the Statutes, amend Part 48, 65, 67 and 69 as follows (new text underlined, deleted text struck through):

‘Part 48: Associate Professor in Transport Studies

...

48.6 Any amendment to Part 48.2 is an amendment to the main objects of the endowment fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by ~~Her~~ His Majesty in Council.’

...

65.11. Any amendment to section 65.3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by **Her His** Majesty in Council.’

‘Part 67: Goodger and Schorstein Fund for Research Scholarships in Medical Science

...

67.8. Any amendment to section 3 of this Part is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by **Her His** Majesty in Council.’

‘Part 69: Scatcherd Scholarships

...

69.10. Any amendment to section 69.3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by **Her His** Majesty in Council.’
