# Council and Main Committees

## Council of the University

Council has made the following changes to regulations, to come into effect on **16 May**, unless notice of a resolution calling upon Council to annul or amend

the regulation is received by the Registrar by **noon on 12 May** (as set out in [Statute VI: Council](#)).

### (1) Council Regulations 14 of 2002: Regulations for Committees

#### *Explanatory Note*

Regulation 2.3 refers to the regulations for student member representatives of council set out in Council Regulations 13 of 2002, which stop at 10.

#### *Text of Regulations*

In [Council Regulations 14 of 2002](#), concerning Committees, amend regulation 22 as follows (new text underlined, deleted text struck through):

‘2.3. The participation by student members in the business of committees of Council shall be subject to the same conditions (with any necessary substitutions) as are prescribed for the student member representatives at meetings of Council under regulations 4–~~14~~10 of the Regulations for Council.’

### (2) Council Regulations 36 of 2002: Regulations for the Visitation Board made under Section 22 of Statute XII

#### *Explanatory Note*

These regulations were updated to refer to the ‘person who is the subject of the complaint’ rather than the ‘member of staff’ and includes two instances that were not updated to match.

#### *Text of Regulations*

In [Council Regulations 36 of 2002](#), Regulations for the Visitation Board made under Section 22 of Statute XII, amend regulation 23 as follows (new text underlined, deleted text struck through):

‘23. (1) Where the case for dismissal, or the ~~member of staff~~person who is the subject of the complaint’s case in response, involves any issue of physical or mental incapacity or capability, the secretary may arrange for the board to be provided with access to expert medical advice in relation to such incapacity or capability or to any steps which may be taken in mitigation of the same.

(2) Where the secretary has arranged for the board to be provided with access to expert medical advice, the ~~member of staff~~person who is the subject of the complaint may be required to make himself or herself available for examination by such medical expert as may be appointed for this purpose and at the University’s expense.’

### (3) Council Regulations 3 of 2004: Regulations for the Employment of University Staff

#### *Explanatory Note*

These regulations refer incorrectly to a list of posts in regulation 24, whereas it is actually included in regulation 25.

#### *Text of Regulations*

In [Council Regulations 3 of 2004](#), Regulations for the Employment of University Staff, amend regulation 23 as follows (new text underlined, deleted text struck through):

‘23. Electoral boards shall be composed as laid down in the detailed provisions for the post in question, on condition that in all cases (with the exception of the posts listed in regulation ~~24~~25 below) they:’.

## (4) Council Regulations 5 of 2006: Regulations for Appeals to the Appeal Court

### Explanatory Note

Previous changes to these regulations retained references that were not changed to align with approved amendments.

### Text of Regulations

In [Council Regulations 5 of 2006](#), concerning Appeals to the Appeal Course, amend regulation 5.3 as follows (new text underlined, deleted text struck through):

‘5.3. If it considers it appropriate to do so the Court may hear appeals by two or more appellants at the same hearing. Appellants shall be invited to make observations which the ~~Panel~~[Court](#) shall take into account before proceeding.

...

6.3 The procedure for considering the matter shall be the procedure set out in Part 3 of ~~these regulations~~[Council Regulations 3 of 2006](#) so far as applicable and, if the Student Disciplinary Panel finds the complaint proved, it shall have the powers referred to in section 46 (2) of Statute XI.’

## Congregation 20 May

### (1) Voting on a Legislative Proposal: Statute IV: Congregation

#### Explanatory Note

It is proposed to correct the reference in Statute IV, concerning Congregation, to which of the sections of Statute VI, concerning Council, are ‘King-in-Council’. The current content is incorrect as a result of a historical oversight.

*WHEREAS it is expedient to correct which Statutes require the approval of His Majesty to be amended, repealed or added to, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of His Majesty in Council, AS FOLLOWS.*

In [Statute IV](#), concerning Congregation, amend §2 (2), regarding which Statutes must have the approval of His Majesty to be changed, as follows (new text underlined, deleted text struck through):

‘2. (1) Any resolution passed by Congregation or other act done or decision taken by Congregation in accordance with the statutes and regulations shall bind the whole University.

(2) A decision taken by Congregation to amend, repeal, or add to any of the following statutes shall not take effect without the approval of His Majesty in Council:

Statute I  
Statute III  
Statute IV (sections 1–4 only)  
Statute V (section 1 only)  
Statute VI (sections 1–~~20~~[18](#) only)  
Statute XII  
Statute XV (sections 1–6 only)  
Statute XVII’.

### (2) Voting on a Legislative Proposal: Prendergast Fund

#### Explanatory Note

The following legislative proposal identifies the board of management for the Prendergast Fund, while retaining Council’s ability to change the board of management on its own authority.

WHEREAS it is expedient to change the existing provisions governing the Prendergast Fund, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of His Majesty in Council, AS FOLLOWS.

In [Part 37 of the Schedule to the University Statutes](#), amend §37.2 as follows (new text underlined, deleted text struck through):

‘37.2. The bequest shall be administered by ~~the~~ [a](#) board of management of [the Oxford Graduate Scholarship](#)

~~Fund which the constitution shall be determined by Council.~~

[37.3. Subject to section 37.4, Council shall have the power to amend, repeal or add to this Part in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the fund to:](#)

[\(1\) cease to be exclusively charitable according to the law of England and Wales; or](#)

[\(2\) be outside the objects of the University.](#)

[37.4 Any amendment to section 37.1 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by His Majesty in Council.’](#)

### (3) Voting on a Legislative Proposal: Part 72 of the Schedule to the Statutes, concerning Samir Shamma Associate Professor in Islamic Numismatics, Epigraphy and Material Culture

#### Explanatory Note

The proposed amendments to Part 72 of the Schedule to the Statutes are to reflect the previous change in name of the Faculty of Oriental Studies to the Faculty of Asian and Middle Eastern Studies.

*WHEREAS it is expedient to update references to reflect the new title of the Faculty of Asian and Middle Eastern Studies, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all*

*other powers enabling it, ENACTS, subject to the approval of His Majesty in Council, AS FOLLOWS.*

In [Part 72 of the Schedule to the Statutes](#), concerning the Samir Shamma Associate Professor in Islamic Numismatics, Epigraphy and Material Culture, amend §§72.4–72.5 as follows (new text underlined, deleted text struck through):

‘72.4. (1) The Associate Professor shall lecture, give instruction and carry out research in Islamic Numismatics, Epigraphy and Material Culture under

the direction of the Board of the Faculty of ~~Oriental Studies~~ [Asian and Middle Eastern Studies](#).

(2) The Associate Professor shall be subject to the General Provisions of the regulations concerning the duties of Associate Professors and to those Particular Provisions of the same regulations which are applicable to this post.

72.5. The administration of the Fund, and the application of its income, shall be the responsibility of the Board of the Faculty of ~~Oriental Studies~~ [Asian and Middle Eastern Studies](#) (“the Board of Management”).’

Council is chaired by the Vice-Chancellor and meets on Mondays of Weeks 1, 4 and 9 of each term (Week 8 in Michaelmas term) and in July and September. Meetings begin at 2pm and usually last for 2–3 hours. Members of Council are the University's charity trustees and have a responsibility for ensuring that Council conducts itself in accordance with accepted standards of behaviour in public life, embracing selflessness, integrity, objectivity, accountability, openness, honesty and leadership. They must also play an appropriate part in ensuring that the business of Council is carried out effectively, efficiently and in a manner appropriate for the proper conduct of public business. Key skills include the ability to see issues from all angles, to discuss and question without being adversarial, to accept collective responsibility for decisions and to exercise common sense across a broad range of matters.

Elected members of Council will ordinarily be expected to serve on a small number of other committees (typically between one and three, usually including at least one of the main committees of Council ie Education Committee, General Purposes Committee, People Committee, Planning and Resource Allocation Committee, Research & Innovation Committee).

The Pool is comprised of 46 persons, elected by Congregation, in 1 of 7 constituencies: 6 members representing each of (1–4) the 4 academic divisions; (5) Gardens, Libraries and Museums; and (6) University Administration and Services; and (7) 10 members of Congregation, not necessarily representing any division and not in any case being nominated in a divisional capacity.

College staff are not covered by Statute XII as colleges have their own statutes. The exception is college staff at Kellogg, St Cross and Reuben, which follow the University's statutes. Any staff holding joint appointments will, however, be covered by Statute XII in respect of their University contract of employment and duties.

This means that all members of Congregation are eligible to nominate a candidate or to vote, but prospective
