Curators are not expected to serve on additional subcommittees/groups (save for the Chair of the University Archives subcommittee, who is appointed by the Curators from among their own number). The Curators would welcome candidates with an interest in the work of the University Libraries.

## POOL FOR CONSTITUTING PANELS UNDER STATUTE XII

- One member of Congregation to whom Statute XII applies to represent the Division of Humanities, elected by Congregation, to serve until HT 2024 [*vice* Dr A J Fairweather-Tall, Humanities Division]

It is expected that candidates for election to represent the Division of Humanities will also be members of the Division of Humanities.

Statute XII applies to: (a) professors, readers and associate professors or lecturers; (b) any employee of the University who is a member of the Universities Superannuation Scheme or who would be a member if he or she had not been exempted under the provisions of Statute XIV. In Statute XII, any reference to ‘a member of the academic staff’ is a reference to a person to whom the statute applies (Statute XII, Section 3 (1) and (2)) (Statute XII, Section 3 (1) and (2)) (<https://governance.admin.ox.ac.uk/legislation/statute-xii-academic-staff-and-the-visitorial-board#collapse1382986>). College staff are not covered by Statute XII as colleges have their own statutes. The exception is college staff at Kellogg, St Cross and Reuben, which follow the University’s statutes. Any staff holding joint appointments will, however, be covered by Statute XII in respect of their University contract of employment and duties.

The terms of reference and membership of this body are set out in Council Regulations 3 of 2017 (<https://governance.admin.ox.ac.uk/legislation/council-regulations-3-of-2017>).

Members of the Pool will be chosen by lot to serve on a number of Panels under Statute XII (ie Redundancy Panel (Section 14 (6)), Staff Employment Review Panel (Section 35) and University Appeal Panel (Section 52 (2)) and may be expected to also chair a Panel. Before serving on a Panel, each member of the Pool will be required to attend appropriate training, including on equality and diversity, which takes about half a day in total. Because members of the Pool are chosen by lot, it is hard to predict how many times a member will be asked to serve, but at the very most this is likely to be 3 Panels in a year (and often fewer), which each take around a day - before the hearing there will also be a large bundle of papers to

read. Nominations from BME staff, from men and from academic and research staff are particularly encouraged. No particular skills/experience are necessary, but an interest in staffing matters is helpful.

### *General requirements and eligibility*

All candidates are asked to note the general requirements which apply to all committee members, as set out in Council Regulations 14 of 2002 (General Regulations of Council for Committees (<https://governance.admin.ox.ac.uk/legislation/council-regulations-14-of-2002>)). Current members seeking re-election are also asked to check for specific restrictions on consecutive service. ### *Candidate’s statement*

Candidates are invited to include with their nomination forms a written statement of no more than 250 words, setting out their reasons for standing and qualifications for the office being sought.

### *Contested elections*

In the event of a contested election, the successful candidates will be determined by an electronic ballot. An email with further instructions will be sent to eligible voters on **Wednesday, 9 November**, using the email addresses provided in the electronic register of Congregation (NB with few exceptions, notably clinical staff, this will be the work



address ending ‘ox.ac.uk’). Candidates’ statements will be published both on the Elections website (<https://governance.admin.ox.ac.uk/elections>) and in the *Gazette* dated Thursday, 10 November. Voters may wish to read these statements before completing their electronic vote. The voting period will close at **4pm on Thursday, 24 November**.

#### *Uncontested elections*

If the number of nominations received by the closing date is no more than sufficient to fill the vacancies, the candidates nominated shall be deemed to be duly elected as of the close of the nomination period on **Thursday, 27 October**. When required, places will be allocated according to academic standing, as defined in Council Regulations 22 of 2002, Part 2: Academic Precedence and Standing (<https://governance.admin.ox.ac.uk/legislation/council-regulations-22-of-2002>). If the number of nominations received by the closing date is less than sufficient to fill the vacancies, those candidates nominated will be deemed elected unopposed, and the remaining vacancies will lapse, in which case, in accordance with the regulations, the places must remain vacant until appointments are made jointly by the Vice-Chancellor and Proctors.

#### *Period of office*

All vacancies are with immediate effect unless otherwise stated. Candidates elected unopposed will take up office as soon as practicable after the result of the election is known (for uncontested elections, this will be as of the close of the nomination period; for contested elections, this will be as of the close of the voting period). In accordance with Congregation Regulations 2 of 2002 (<https://governance.web.ox.ac.uk/legislation/congregation-regulations-2-of-2002>), in any election where vacancies are to be filled for periods of different length, the elected candidates shall hold office so that the tenure of those who receive more votes shall be longer than that of those who receive fewer votes; but if the election is uncontested or if two candidates receive the same number of votes, the candidate senior in academic standing shall hold office for the longer period.
