General Purposes Committee of Council

The General Purposes Committee of Council has made the following changes in regulations, to come into effect on **7 May**.

(a) Establishment of the Bennett Chair of Evidence-Based Medicine

Explanatory Note

These changes, made on the recommendation of the Medical Sciences Board, establish the Bennett Chair of Evidence-Based Medicine Fund to endow a new professorship of Evidence-Based Medicine.

Text of Regulations

1 In the Schedule of Statutory Professorships annexed to Council Regulations 3 of 2004, insert:

'Bennett Professor of Evidence-Based Medicine'.

2 In Council Regulations 24 of 2002, concerning individual professorships, insert:

'Bennett Professor of Evidence-Based Medicine

1. The Bennett Professor of Evidence-Based Medicine shall undertake research in Evidence-Based Medicine and shall lecture and give instruction in this subject.

2. The professor shall be elected by an electoral board consisting of:

 (1) the Vice-Chancellor, or if the head of the college specified in paragraph
 (2) below is the Vice-Chancellor, a person appointed by Council;

(2) the head of the college to which the professorship may be allocated by Council from time to time; or if the head is unable or unwilling to act, a person appointed by the governing body of that college;

(3) a person appointed by the governing body of the college specified in paragraph (2) above; (4)-(5) two persons appointed by Council;

(6)-(9) four persons appointed by the Medical Sciences Board;

(10) a person holding a clinical appointment appointed by the relevant NHS body with which the post-holder may hold an honorary contract.

3. The professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.

(b) Establishment of the Kavli Institute for NanoScience Discovery Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the gift from the Kavli Foundation.

Text of Regulations

In Council Regulations 25 of 2002, insert:

'Kavli Institute for NanoScience Discovery Fund

1. The University receives with gratitude a gift from The Kavli Foundation ("the Benefactor") to be held as permanent endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Kavli Institute for NanoScience Discovery Fund ("the Fund") and the academic research activity supported by the Fund will be undertaken within the Kavli Institute for NanoScience Discovery ("the Institute").

2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment; and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, to support academic research activity in the field of NanoScience within the Institute.

4. The administration of the Fund, and the application of its income, shall be the responsibility of a dedicated management board convened for that purpose ("the Management Board").

5. In the period ending 21 years from 6 November 2020, the University may on the recommendation of the Management Board and with the prior approval of the Benefactor (such approval not to be unreasonably withheld, conditioned or delayed)1 instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, the management and administration of the Fund provided that the amount payable under this regulation 6 in each year shall not exceed 0.3 per cent of the aggregate of the income of the Fund and any other annual payments payable by the Benefactor in such year to support the Institute.

7. The University may exercise any of its corporate powers in the management and administration of the Fund in so

far as those powers are not inconsistent with these regulations.

8. Regulations 1-10 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

9. Subject to regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI with the prior written approval of the Benefactor¹ (such approval not to be unreasonably withheld, conditioned or delayed), but no amendment is valid if it would cause the Fund to:

(1) cease to be exclusively charitable according to the law of England and Wales; or

(2) be outside the objects of the University.

10. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.

(c) Establishment of the Oxford University Ice Hockey Project Endowment Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of gifts to promote participation in the sport of ice hockey in particular among student members of the University.

Text of Regulations

In Council Regulations 25 of 2002, insert:

'Oxford University Ice Hockey Project Endowment Fund

1. The University receives with gratitude funds to be held as permanent endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either permanent or expendable endowment to be held on the same trusts. The assets so held will be known as the Oxford University Ice Hockey Project Endowment Fund (the "Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment (the "Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment; and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the promotion of participation in the sport of ice hockey in particular among student members of the University (the "Trust Purpose"). For so long as the Oxford University Ice Hockey Club (the "Club") exists and continues to have exclusively charitable objects, the University shall advance the Trust Purpose exclusively through the application of funds to the Club.

4. The administration of the Fund, and the application of its income, shall be the responsibility of a board of management comprised of majority University representatives with a representative appointed by the Club and a representative appointed by the Club's alumni body. All members of the board of management will be appointed subject to the approval of the Sports Strategic Subcommittee of the Education Committee.

5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

6. The University shall have power to pay out of the capital or the income

of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund and the Trust Purpose (provided, however, that such costs shall not exceed the amount charged by the University to any other of its trust funds of a comparable size).

7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

8. Regulations 1-10 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

9. Subject to regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

(1) cease to be exclusively charitable according to the law of England and Wales; or

(2) be outside the objects of the University.

10. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.

(d) Establishment of the Tanner Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the gift for the promotion of participation in the sport of athletics in particular among student members of the University.

Text of Regulations

In Council Regulations 25 of 2002, insert:

'Tanner Fund

1. The University receives with gratitude the initial sum of £200,000 to

be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either permanent or expendable endowment to be held on the same trusts. The assets so held will be known as the Oxford University Athletics Fund, or the Tanner Fund (the "Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment (the "Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the promotion of participation in the sport of athletics in particular among student members of the University (the "Trust Purpose"). For so long as the Oxford University Athletics Club (the "Club") exists and continues to have exclusively charitable objects, the University shall advance the Trust Purpose exclusively through the application of funds to the Club.

4. The administration of the Fund, and the application of its income, shall be the responsibility of a board of management comprised of three individuals: two appointed by the Sports Strategic Subcommittee; and one appointed by the Club with the approval of the Sports Strategic Subcommittee.

5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year. 6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund and the Trust Purpose.

7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

8. Regulations 1-10 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

9. Subject to regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

(1) cease to be exclusively charitable according to the law of England and Wales; or

(2) be outside the objects of the University.

10. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.

(e) Waynflete Professorship of Chemistry

Explanatory Note

The following changes, made on the recommendation of the Mathematical, Physical and Life Sciences Division and the Department of Chemistry, update outdated wording and references in the regulations.

Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships, amend the Waynflete Professorship of Chemistry (new text underlined, deleted text struck through):

'Waynflete Professor of Chemistry

1. The Waynflete Professor of Chemistry shall <u>undertake research in and</u> <u>shall</u> lecture and give instruction in theoretical and practical Chemistry, especially Organic Chemistry<u>, and</u> shall generally promote its study in the <u>University</u>.

2. The professor shall be elected, by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the President of Magdalen College is Vice-Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;

(2) the President of Magdalen College, or, if the President is unable or unwilling to act, a person appointed by the governing body of Magdalen College on the occurrence of a vacancy to act as an elector on that occasion;

(3) a person appointed by the Governing Body of Magdalen College;

(4)<u>(5)</u> a two persons appointed by Council;

(5) a person appointed by the General Board;

(6)-(8)(<u>9</u>) threefour persons appointed by the Board of the Faculty of the Physical Sciences Mathematical, Physical and Life Sciences Board.

(9) a person elected by the Boardof the Faculty of the Biological-Sciences.

3. The professor shall be subject to the General Provisions of the decree<u>regulations</u> governing the duties of professors and to those Particular Provisions of the same decree<u>regulations</u> which are applicable to this chair.'
