A legislative proposal and explanatory note on changes to Congregation Regulations 3 of 2002, concerning the Conduct of Ceremonies in Congregation, and certain other Ceremonies, were published in [Gazette No 5451, 20 March 2025, p415.](#)

Two notices of opposition and one notice of amendment have been received to that legislative proposal, as set out below.

## Arrangements for the meeting

The meeting will be held at 2pm on Tuesday, 29 April, in the Sheldonian Theatre. The doors will be opened at 1.30pm.

Attendance at the meeting is open to members of Congregation and nominated members of Oxford SU. Admittance to the theatre will be on production of a member's University Card stating 'Congregation', and will be on a first-come first-served basis. Since it is possible that some members will not have been issued with a new card, identity may also be checked against the Register of Congregation at the entrance. Please make sure that the details on cards are legible. New cards may be obtained from the University Card Office. Information on eligibility requirements for membership of Congregation and how to apply is published at <https://governance.admin.ox.ac.uk/congregation>.

The Vice-Chancellor has decided that the wearing of gowns shall be optional on this occasion.

## ORDER OF BUSINESS

Congregation is permitted to approve or reject the amended proposal.

The Proctors have recommended that postponement to a second meeting of Congregation (as per regulation 2.10 (1)(a)) is not required.

The Chair will open the meeting at 2pm and set out the procedure and order of business as follows:

- The resolutions at (1)–(3) authorising the allocation of space will be declared carried.
- The Legislative Proposal at (4) will be moved and seconded on behalf of Council.
- The two notices of opposition will be moved.
- The proposed amendment will be moved and seconded.
- Speeches will be invited in support of or opposition to the proposed amendment as time permits.
- The mover of the amendment will be given the opportunity to respond.
- The proposed amendment will be put to Congregation in a round of voting by paper ballot (1 – see 'Voting' section below).

*If the amendment is rejected*, further speeches will be invited in support of or in opposition to the legislative proposal as time permits, the movers of the notices of opposition to the legislative proposal and the mover of the legislative proposal will be given the opportunity to respond to the debate, following which there will be a vote by paper ballot to pass or reject the legislative proposal (2).

*If the amendment is carried*, Congregation will vote on the amended legislative proposal (3).

### VOTING

Voting on the legislative proposal in the meeting of Congregation will be determined by paper ballot. Three voting papers will be handed out on arrival: for or against the amendment (1), for or against the original legislative proposal (2) and (3) for or against the amended legislative proposal.

### Notice of Amendment

Under [regulation 2.6 of Congregation Regulations 2 of 2002](#), the Vice-Chancellor, in consultation with the Proctors, has reported the following amendment to Council as in her judgement being a true amendment and not an alternative proposal.

#### *Explanatory Note*

The intention of this amendment to the proposed changes to Congregation Regulations 3 of 2002 is to restore a version of the salutation to the formula used by the Proctors for charging those admitted to certain higher degrees (§3.14), to the relevant formulae for incorporation (§§3.28 and 3.29), and to the formulae for admission used by the Vice-Chancellor (§4.4).

#### *Proposal*

We – Franklins and Katz – were charged with adjusting the Latin used in the University's ceremonial contexts so as to ensure that the language used in ceremonies is compliant and consistent with the Higher Education Statistics Agency (HESA) and UCAS data. Our intention was to make as few changes as possible to the ancient and well-beloved language of our ceremonies, while making the adjustments required by this undertaking.

Every noun and adjective in Latin has a grammatical gender but not all words make that grammatical gender conspicuous in the shape of the form they take (i.e. the grammatical masculine and feminine are indistinguishable in appearance); we sought to redraft the formulae to use such nouns and adjectives.

The salutations in question consist of three words: *Doctor*, *Magister*, and *Dominus*. The one of these that is used most frequently in the current formulae is *Dominus*: this is a form that, in its termination, unavoidably displays grammatical gender (*Dominus*, *Domina* etc.). In an earlier version of the proposed changes to the regulations, an attempt that had been made to preserve the salutations was deemed unsatisfactory in the course of discussion and consultation with the conclave of Deans of Degrees, with members of the Degree Conferrals Advisory Group (DCAG), and with other colleagues. In the light of the resistance met in these discussions, the proposal in its current form was drawn up in consultation with a number of Deans of Degrees and approved by DCAG before passing onto General Purposes Committee and Council for approval.

We recognise, however, that there are reasons for wanting to maintain the salutations: among these are that they form part of the tradition handed down to us and they connote the respect shown by University Officers to graduands in the ceremony. In the light of this, we propose the following. Salutations should be restored to §§3.14, 3.28, 3.29, and 4.4 on this basis, which avoids the conspicuousness of gendered forms:

– *Doctor* (pl. *Doctores*) and *Magister* (pl. *Magistri*) should be used where necessary for any individual without inflecting the gender of either noun: they are statuses. We do not, after all, refer to a woman with a doctorate as a ‘Doctrix of Philosophy’, nor a woman with an MA as a ‘Mistress of Arts’; the same would be true in the Latin. This would be in keeping with usage elsewhere in the formulae.

– As noted above, *Dominus* causes problems, and we would suggest replacing it with *Sodalis* (pl. *Sodales*) a noun that is of common gender, that is, it has the same form regardless of the gender of the person to whom it refers (cf. s.v. *sodalis* in *Lewis & Short* and in the *Dictionary of Medieval Latin from British Sources*).

In other words, the salutation at the start of the formulae in question would read thus:

- §3.14: *Doctores, Magistri (or Sodales), vos dabit* ...
- §3.28: *Magister (or Sodalis or Doctor), tu dabis* ...
- §3.29: *Sodalis (or Magister or Doctor), ego admitto* ...
- §4.4(1, 3, 11): *Sodalis (or Sodales), ego admitto* ...
- §4.4(2, 4–10, 12–15, 17–22): *Sodalis or Magister (or Sodales or Magistri), ego* ...
- §4.4 (16): *Sodales, ego admitto* ...

[The more eagle-eyed among colleagues may have noticed that *Baccalaureus* – which looks like it should change its ending according to gender – is tolerated in, e.g., §4.3(2). This word is deemed acceptable, since *Baccalaureus* is being treated as a status, along the lines of *Magister* and *Doctor*, and will thus only be found in the second declension (i.e. with the endings *-um, -os*) in the formulae; we do not have Bachelorettes or Spinsters of Arts. The nature of *Dominus* is different, as it does not refer to a status but means ‘Sir’ (and *Domina*, ‘Madam’).]

Any staff holding joint appointments will, however, be covered by Statute XII in respect of their University contract of employment and duties.

This means that all members of Congregation are eligible to nominate a candidate or to vote, but prospective candidates who want to stand for election must be a member of Congregation to whom [Statute XII](#) applies. By convention, it is expected that candidates for election to represent this constituency will work within University Administration & Services.
