# Council and Main Committees

## Council of the University

### Changes in Regulations

Council has made the following changes in regulations, to come into effect on **11 May**.

#### (a) Continuing Education Board

##### *Explanatory Note*

These changes, made on the recommendation of the Continuing Education Board, amend the membership of the board to allow firstly for a member appointed by the Conference of Colleges and secondly for a student representative.

##### *Text of Regulations*

**1** In Part 16 of Council Regulations 15 of 2002 concerning the Continuing Education Board (Supplement (2) to *Gazette* No 4628, 26 June 2002, p 1398, as amended on 23 March 2006, 7 June 2007, 29 May 2008 and 25 June 2010 and renumbered on 28 July 2011) delete existing regulation 16.1 and substitute (new text underlined, deleted text scored through):

'16.1. The Continuing Education Board shall consist of:

(1), (2) one or two members appointed by Council from among its own members (as determined from time to time by Council, bearing in mind the desirability of there being strong representation of the board on Council and its committees, particularly the Education and Planning and Resource Allocation Committees), of whom one shall be designated chairman of the board by the Vice-Chancellor after consultation with the Director of the Department for Continuing Education;

(3)-(6) four persons of whom one shall be appointed by each divisional board;

(7)-(9) the Director and Deputy Directors of the Department for Continuing Education;

(10)-(12) three other members of the Department for Continuing Education elected by and from among the members of the department;

(13) one person appointed by the Conference of Colleges. They shall

have appropriate experience and understanding of academic policy and finance and be familiar with continuing education, but should not hold a salaried teaching or research post within the Department for Continuing Education.'

**2** *Ibid.*, after existing regulation 16.2 insert new regulation 16.3 as follows and renumber existing regulation 16.3 as 16.4:

'16.3. Student members shall have the right to be represented at meetings of the Continuing Education Board in accordance with Part 1 of these regulations and under the arrangements set out below:

(1) The student body shall be represented at the board by one student member working for an award under the aegis of the board.

(2) The representative shall be nominated as agreed between the student body and the board from amongst the student representatives on the academic committees of the Department for Continuing Education.

(3) More than one representative may be nominated under the provisions of (2) above, in which case the representatives shall decide between them which one shall attend any given meeting of the board.

(4) The representative(s) shall serve for one year, and shall be eligible for re-nomination if they remain working for an award under the aegis of the board.'

**3** These changes shall be effective from 1 October 2012.

#### (b) Finance Committee

##### *Explanatory Note*

The following amends the regulations of the Finance Committee to increase its external membership from three to four.

##### *Text of Regulations*

In Part 19 of Council Regulations 15 of 2002 (made by Council on 26 June 2002, as amended on 1 June 2006, 22 May 2008 (date of effect 1 October 2008), 18 March 2010, 22 July 2010 and 27 October 2011), delete regulation 19.1 and substitute

(deleted text scored through, inserted text underlined):

'19.1. The Finance Committee shall consist of:

(1) the Vice-Chancellor;

(2)-(5) Three ~~four~~ external persons appointed by Council, of whom at least two shall be members of Council;

(6) a person appointed by Council from among the members of Council elected by Congregation;

(7) a Head of House appointed by the Conference of Colleges.'

## General Purposes Committee of Council

### Changes in Regulations

The General Purposes Committee of Council has made the following changes in regulations, to come into effect on **11 May**.

#### (a) Establishment of Department of Physics Prize Fund

##### *Explanatory Note*

These regulations establish the 'Department of Physics Prize Fund' for the purpose of awarding prizes and/or bursaries to students studying or undertaking research at the Department of Physics. It is intended that by resolution of Council, as trustee, under the Charities Act 2011, the Arthur William Scott Fund, David Ryan Memorial Fund, Johnson Memorial Prizes Fund and John Thresher Memorial Prize Fund shall be transferred and administered as part of this new fund (see 'Notices' section below, p 471). Once the existing regulations of the aforementioned funds have been transferred to the new Department of Physics Prize Fund, the existing regulations will serve no further purpose and shall therefore be deleted.

##### *Text of Regulations*

In Part 2 of Council Regulations 25 of 2002 concerning trusts (*Statutes*, 2000, p 707, as redesignated as regulations by Decree (5) of 11 July 2002, *Gazette*, Vol 132, p 1461), insert new § 283 as follows, and renumber existing §§ 283-394 as §§ 284-395:

**'§ 283. Department of Physics Prize Fund**

1. Ten pounds and such further money or property as may be paid or transferred to be held by the University on the same trusts shall be held together as part of the Department of Physics Prize Fund ("the Fund"), which shall be held on the trusts declared in this regulation.
2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
3. The University shall (1) apply the income of the Permanent Endowment; and (2) apply the income and, in its discretion, the capital of the remainder of the Fund (if any), towards awarding prizes and/or bursaries to students studying or undertaking research at the Department of Physics.
4. The administration of the Fund, and the application of its income, shall be the responsibility of the Physics Management Committee, which may make and amend Standing Orders consistent with these regulations governing the administration of the Fund and the application of its income.
5. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund.
6. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
7. Subject to regulation 8, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
8. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

**(b) Establishment of Department of Physics Special Lecture Fund***Explanatory Note*

These regulations establish the 'Department of Physics Special Lecture Fund' for the purpose of advancing teaching and research at, or in connection with, the Department of Physics, with emphasis on the provision of special lectures. It is intended that by resolution of Council, as trustee, under the Charities Act 2011, the Simon Cherwell Memorial Lecturer Fund and Halley Lecturer on Astronomy and Terrestrial Magnetism Fund will be transferred and administered as part of this new fund (see 'Notices' section below, p 471). Once the existing regulations of the aforementioned funds have been transferred to the new Department of Physics Special Lecture Fund, the existing regulations will serve no further purpose and shall therefore be deleted.

*Text of Regulations*

In Part 2 of Council Regulations 25 of 2002 concerning trusts (*Statutes*, 2000, p 707, as redesignated as regulations by Decree (5) of 11 July 2002, *Gazette*, Vol 132, p 1461), insert new § 284 as follows, and renumber existing §§ 284–395 as §§ 285–396:

**'§ 284. Department of Physics Special Lecture Fund**

1. Ten pounds and such further money or property as may be paid or transferred to be held by the University on the same trusts shall be held together as part of the Department of Physics Special Lecture Fund ("the Fund"), which shall be held on the trusts declared in this regulation.
2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
3. The University shall (1) apply the income of the Permanent Endowment; and (2) apply the income and, in its discretion, the capital of the remainder of the Fund (if any), towards the advancement of teaching and research at, or in connection with, the Department of Physics, with emphasis on the provision of special lectures.
4. The administration of the Fund, and the application of its income, shall be the responsibility of the Physics Management Committee, which may make and amend Standing Orders consistent with these regulations governing the administration of the Fund and the application of its income.

5. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund.

6. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

7. Subject to regulation 8, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

(1) cease to be exclusively charitable according to the law of England and Wales; or

(2) be outside the objects of the University.

8. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

**(c) Establishment of English Language and Literature Prize Fund***Explanatory Note*

These regulations establish the 'Faculty of English Language and Literature Prize Fund' for the purpose of awarding prizes to candidates who have shown academic excellence in courses offered by the Faculty of English Language and Literature.

It is intended that by resolution of Council, as trustee, under the Charities Act 2011, the Oldham Shakespeare Prize Fund, English Poem on a Sacred Subject Fund, Lord Alfred Douglas Memorial Prize Fund, Matthew Arnold Memorial Prize Fund, Passmore Edwards Prize Fund and Shelley Mills Prize Fund shall be transferred and administered as part of this new fund (see 'Notices' section below, p 471). It is also intended that half of the Beddington Prizes Fund and the Newdigate Prize Fund shall be administered as part of this new fund, with the other half being administered by the Faculty of Medieval and Modern Languages and University College respectively.

*Text of Regulations*

In Part 2 of Council Regulations 25 of 2002 concerning trusts (*Statutes*, 2000, p 629, as redesignated as regulations by Decree (5) of 11 July 2002, *Gazette*, Vol 132, p 1461), insert new § 106 as follows, and renumber existing §§ 106–78 as §§ 107–79:

**'§ 106. Faculty of English Language and Literature Prize Fund**

1. Ten pounds and such further money or property as may be paid or transferred to be held by the University on the same trusts shall be held together as part of the English Language and Literature Prize Fund ("the Fund"), which shall be held on the trusts declared in this regulation.

2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (1) apply the income of the Permanent Endowment; and (2) apply the income and, in its discretion, the capital of the remainder of the Fund (if any), towards awarding prizes to candidates who have shown academic excellence in courses offered by the Faculty of English Language and Literature.

4. The administration of the Fund, and the application of its income, shall be the responsibility of the Faculty of English Language and Literature Board, which may make and amend Standing Orders consistent with these regulations governing the administration of the Fund and the application of its income.

5. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund.

6. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

7. Subject to regulation 8, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

(1) cease to be exclusively charitable according to the law of England and Wales; or

(2) be outside the objects of the University.

8. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation

If no such notice has been given, and unless Council has declared otherwise, the legislative proposals shall be carried, and the meeting may be cancelled.

**(1) Voting on Legislative Proposal: deputy chairmen of Council**

*Explanatory Note*

In 2010, Council established a Governance Working Group to make proposals on how to take forward the remaining recommendations of the Audit and Scrutiny Committee's Governance Report (online at [www.ox.ac.uk/governance](http://www.ox.ac.uk/governance)), one of which proposed the appointment of an external chairman of Council. The Group reported to Council in June and recommended, *inter alia*, that rather than making changes to the chairmanship of Council, arrangements should be put in place for two deputy chairs of Council to be appointed for a defined period, being a Pro-Vice-Chancellor to chair Council should the Vice-Chancellor be unable to do so for reasons other than a conflict of interest, and an external member of Council to chair Council for those agenda items where the Vice-Chancellor had a conflict of interest. The following legislative proposal, approved by Council, implements that recommendation.

*WHEREAS it is expedient to establish two deputy chairmen of Council, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of Her Majesty in Council, AS FOLLOWS.*

**1** In Statute VI concerning Council (Supplement (1) to the *Gazette* No 4633, 9 October 2002, as amended), delete sections 6 and 7 and substitute (new text underlined, deleted text scored through):

'6. Council may, but is not obliged to, co-opt up to three members of Congregation as additional members of Council, one of whom may serve as a deputy chairman of Council under section 7 (4)(a)(ii) below.



7. (1) The Vice-Chancellor, or, in his or her absence, a member of Council deputed by the Vice-Chancellor, a Pro-Vice-Chancellor appointed as chairman under section 10 (3) below, shall normally take the chair at all meetings of Council.

(2) In the event that the person under sub-section (1) above cannot or should not act as chairman, a member of Council serving as deputy chairman shall take the chair.

(3) The chairman shall and have a second or casting vote in the event of equality of voting.

(4) (a) Council may appoint up to two deputy chairmen:

(i) an external member of Council, appointed under section 4 (7)–(10) above, who shall take the chair for the discussion of items of business in which the chairman of the Council meeting has a conflict of interest;

(ii) a Pro-Vice-Chancellor, appointed under regulation 9 of Council Regulations 21 of 2002, who shall take the chair when the chairman cannot or should not act as chairman for reasons other than a conflict of interest.

(b) In the absence of the appropriate deputy chairman appointed under (a) above at a meeting, the Vice-Chancellor or the Pro-Vice-Chancellor appointed as chairman of Council under section 10 (3) shall have discretion to appoint an alternate.

(5) The appointment of a deputy chairman under sub-section (4) above shall be made on the recommendation of the Vice-Chancellor or the Pro-Vice-Chancellor appointed as chairman of Council under section 10 (3).

(6) Where a person is appointed as deputy chairman under sub-section (4)(a)(ii) above who is not a member of Council when appointed, that person shall thereupon become a co-opted member of Council and shall remain a member of Council for as long as he or she remains a deputy chairman.

(7) Each deputy chairman shall hold office for a period of up to four years and shall be eligible for reappointment.

(8) Each deputy chairman may exercise all the functions of the chairman at any meeting when the chairman cannot or should not act.

2 Ibid., delete section 8 (3) and substitute:

'(3) (a) Members of Council co-opted under section 6 may serve for a period of up to four years and shall be eligible to serve for a second consecutive period of up to four years.

(b) The term of a person whose co-optation is made expressly subject to an appointment under section 7 (4)(a)(ii) will expire on the appointment of a deputy chairman who is not when appointed a member of Council.'

## **(2) Voting on Legislative Proposals: Scatcherd Scholarships**

### **(i) Scatcherd Science Scholarships, for the support of graduate study in science**

#### *Explanatory Note*

The following legislative proposal amends the name and the board of management of the Scatcherd Scholarships for the support of graduate study in science and brings the restriction on candidates in line with the Equality Act 2010 by targeting persons who are ordinarily resident in (rather than those from, which implies and has historically been construed as citizens of) a number of European countries. In addition, it is proposed to update the mechanics for amending the trust to reflect the University's current practice and the trust's new status as a scheduled trust.

*WHEREAS it is expedient to change the existing provisions governing the Scatcherd Scholarships, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of Her Majesty in Council, AS FOLLOWS.*

In the Schedule to the Statutes (Supplement (1) to Gazette No 4633, 9 October 2002, pp 133–59), after Part 71 insert the following new Part 72<sup>1</sup> (new text underlined, deleted text scored through):

### **'§ 318. Part 72: Scatcherd Science Scholarships**

72.1. The University accepts from the Trustee of the Campaign for Oxford Trust Fund the sum of £621,000, made possible by an extremely generous benefaction from Mrs Jane Ledig-Rowohl, to establish a fund, the net income of which shall be applied in the funding of Scatcherd Science Scholarships for the support of graduate study in science.

72.2. The fund shall be administered by the International Committee. The administration of the Fund, and the application of its income, shall be the

responsibility of the board of management of the Oxford Graduate Scholarship Fund.

72.3. The scholarships shall be awarded to persons from ordinarily resident in any European country (other than the UK or Turkey but including Russia and all other countries to the west of the Urals) to enable them to study for a graduate degree of the University in a science subject (including mathematics and medicine). The committee board of management shall endeavour to ensure that at any one time one of the scholarships shall be held by a person from ordinarily resident in a country outside the European Union.

72.4. Any income not spent in any year shall be carried forward for expenditure in subsequent years.

72.5. Congregation Council shall have power to alter this decree Part from time to time, provided that other than the main object of the fund, as defined in clause 1 section 72.1 above, is always kept in view.'

*Regulations to be made by Council if the Statute is approved by Her Majesty in Council*

2 This regulation shall be effective from the date on which the Statute approved by Congregation on [date] is approved by Her Majesty in Council.

### **(ii) Scatcherd Scholarships, for students undertaking any course of study at Oxford, and Oxford students studying in other countries**

#### *Explanatory Note*

The following legislative proposal, concerning the Scatcherd Scholarships for students undertaking any course of study at Oxford, and Oxford students studying in other countries, brings the restriction on candidates in line with the Equality Act 2010 by targeting persons who are ordinarily resident in (rather than citizens of) a number of European countries.

*WHEREAS it is expedient to change the existing provisions governing the Scatcherd Scholarships, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of Her Majesty in Council, AS FOLLOWS.*

In the Schedule to the Statutes (Supplement (1) to *Gazette* No 4633, 9 October 2002, pp 133–59), after Part 72 insert the following new Part 73<sup>1</sup> (new text underlined, deleted text scored through):

**'§319. Part 73: Scatcherd Scholarships**

73.1. The University has received with gratitude a legacy from Mrs Jane Ledig-Rowohl to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University to be held on the same trusts. The assets so held will be known as the Scatcherd Scholarship Fund ("the Fund").

73.2. The University shall retain as permanent endowment those of the assets (if any) in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

73.3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards: (i) awarding scholarships to students of Oxford University of British citizenship allowing them to engage in study or research in other countries; and (ii) awarding scholarships to citizens of students ordinarily resident in a nation of continental Europe from the Atlantic to the Urals with the exception of Turkey.

73.4. The administration of the Fund, and the application of its income and capital, shall be the responsibility of the board of management of the Oxford Graduate Scholarship Fund.

73.5. The University may in its absolute discretion in the period ending on 27 February 2033 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

73.6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund and the Scholarship

73.7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

73.8. ~~Regulations~~ Sections 73.1–73.10 shall be deemed to be trust Regulations provisions under the provisions of Part D of Statute XVI.

73.9. Subject to ~~regulation section~~ 73.10, Council may amend, repeal or add to these regulations provisions in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

- (1) cease to be exclusively charitable according to the law of England and Wales; or
- (2) be outside the objects of the University.

73.10. Any amendment to regulation section 73.3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.<sup>1</sup>

#### **Consultation on proposed changes to the University of Oxford Staff Pension Scheme**

Members of the University of Oxford Staff Pension Scheme (OSPS), and members of support staff who are not members but

who are eligible to join, are being consulted on proposed changes to the OSPS pension scheme.

The proposals under consideration have been put forward by the OSPS Review Group established by Council and follow extensive consultation with the OSPS Trustees, the staff representatives of the major trades unions representing OSPS members (Unison and Unite) and the Joint Committee with University Support Staff.

In addition to the University, there are a number of colleges and other associated University bodies who are employers in the scheme. College interests have been represented in the Review Group. As required by statutory regulations, the University, colleges and other employers are each conducting separate but parallel consultations of their staff.

The consultation period is running from 20 April to 19 June 2012. After consideration of the views put forward during the consultation, the Review Group will make final, formal recommendations to the employers, Trustees and trades unions over the summer with a view to implementation on 1 January 2013.
