Changes in Regulations

Council has made the following changes in regulations, to come into effect on **11 November.**

(a) Quorum of committees

Explanatory Note

Following approval by Her Majesty in Council of amendments to Statute VI (see p. 98), the changes below establish the quorum requirements for Council and for committees reporting directly to Council or one of its main committees.

Text of Regulations

1 In Council Regulations 13 of 2002 (Supplement (2) to *Gazette* No. 4628, 26 June 2002, as amended on 8 May 2003, 14 and 21 January 2010, *Gazette*, Vol. 139, p. 1244, 11 June 2009; Vol. 140, pp. 405 and 444), insert the heading and new regulations 1–2 below and renumber existing regulations 1–10 as 3–12:

'Quorum

1. (1) In accordance with section 19 of Statute VI, no business shall be transacted at any meeting of Council unless a quorum is present.

(2) A quorum is one third plus one of those members eligible to vote upon Council business (rounded to the nearest integer).

(3) A member who is participating in a meeting by telephone, video-conference or any other means of communication which permits all members simultaneously to hear one another, shall be considered present and therefore shall count towards the quorum.

2. If:

(1) a quorum is not present within half an hour from the time appointed for the meeting; or

(2) during a meeting a quorum ceases to be present

the business or remaining business of that meeting shall be deferred to another

meeting, whether already scheduled or to be scheduled, or shall be dealt with by the Vice-Chancellor acting under delegated authority in accordance with Council's Standing Orders.'

2 In Part 1 of Council Regulations 15 of 2002 concerning committees reporting directly to Council or one of its main committees (Supplement (2) to *Gazette* No. 4628, 26 June 2002, as amended), after existing regulation 1.5 insert new regulations 1.6–1.7 as follows:

'1.6. (1) No business shall be transacted at any meeting of a committee reporting directly to Council or one of its main committees unless a quorum is present.

(2) In the absence of provision in these regulations for a larger quorum, a quorum is one third of those members eligible to vote upon the business of the committee in question (rounded to the nearest integer).

(3) A member who is participating in a meeting by telephone, video-conference or any other means of communication which permits all members simultaneously to hear one another, shall be considered present and therefore shall count towards the quorum.

1.7. If:

(1) a quorum is not present within half an hour from the time appointed for the meeting; or

(2) during a meeting a quorum ceases to be present

the business or remaining business of that meeting shall be deferred to another meeting, whether already scheduled or to be scheduled, or shall be dealt with by the chairman acting under delegated authority in accordance with the committee's standing orders.'

3 Ibid., in Part 19 concerning the Finance Committee, after existing regulation 19.4 insert new 19.5 below:

'19.5. Regulations 1.6 and 1.7 in Part 1 apply to this committee except that the quorum is one third plus one of those members eligible to vote upon the business of the committee (rounded to the nearest integer).' **4** Ibid., in Part 29 concerning the Socially Responsible Investment Review Committee, after existing regulation 29.5 insert new 29.6 below:

'29.6. Regulations 1.6 and 1.7 in Part 1 apply to this committee except that the quorum is one third plus one of those members eligible to vote upon the business of the committee (rounded to the nearest integer).'

'34.8. Regulations 1.6 and 1.7 in Part 1 apply to this subcommittee except that the quorum is one third plus one of those members eligible to vote upon the business of the committee (rounded to the nearest integer).'

(b) Removal of Council members

Explanatory Note

Following approval by Her Majesty in Council of amendments to Statute VI concerning the removal of Council members (see p. 98), the changes below are consequential changes to the regulations.

Text of Regulations

1 In Council Regulations 14 of 2002 (Supplement (1) to *Gazette* No. 4634, 16 October 2002, Vol. 133, p. 225, as amended on 21 October 2004, 30 November 2006 and 20 January 2011, *Gazette*, Vol. 135, p. 245; Vol. 137, p. 458; Vol. 141, p. 332) delete regulation 1 and substitute (new text underlined and deleted text scored through):

'1. These regulations shall apply both to Council and to any 'committee' of the University as defined in section 6 (3) of Statute I.'

2 Ibid., delete existing regulation 6 and substitute:

'6. Existing membership of all committees including Council shall terminate automatically on taking office as Proctor or Assessor.'

3 In Council Regulations 21 of 2002 concerning University officers (Supplement (2) to *Gazette* No. 4628, 26 June 2002, Vol. 132, p. 1417, as amended on 24 February 2005, 23 March 2006, 19 March 2008 and 26 June 2009, *Gazette*, Vol. 135, pp. 686, 837; Vol. 138, pp. 837-8, Vol. 140, p. 1300) delete regulation 7 and substitute:

'7. (1) In the event of the incapacity or the initiation of the removal procedure <u>under Part G of Statute XII</u> or absence from Oxford of the Vice-Chancellor, or in the event of a vacancy in the Vice-Chancellorship, one of the Pro-Vice-Chancellors shall be appointed Acting Vice-Chancellor.

(2) In the event that the Vice-Chancellor's membership of Council is terminated under section 9 (1) of Statute VI, one of the Pro-Vice-Chancellors shall be appointed chairman of Council.

(23) The appointment shall be made:

(*a*) by the Vice-Chancellor <u>in the</u> <u>event of incapacity or absence</u>, if the incapacity or absence is unlikely to be longer than two months;

(b) by the Chancellor if the incapacity or absence is likely to be for longer than two months, <u>or the removal</u> procedure under Part G of Statute XII has been initiated, or membership of <u>Council has been terminated</u>, or after an appointment under (*a*) has lasted for two months, or in the event of a vacancy in the Vice-Chancellorship;

(c) by Council in default of an appointment under (a) or (b).'

General Purposes Committee of Council

Changes in Regulations

The General Purposes Committee of Council has made the following changes in regulations, to come into effect on **11 November.**

Wood Professor of Forest Science

Explanatory Note

These revised regulations replace the existing regulations for the Wood Professor of Forest Science to clarify that the post is endowed and to provide for the possibility of future donations, which may be treated as permanent endowment depending on the wishes of the donor(s).

Text of Regulations

In Section III of Council Regulations 24 of 2002 concerning individual professorships (*Statutes*, 2000, p. 423, as redesignated as regulations by Decree (5) of 11 July 2002, *Gazette*, Vol. 132, p. 1461), delete existing § 95 and substitute:

'§ 95. Wood Professor of Forest Science

1. There shall be a Wood Professor of Forest Science, who will be a distinguished specialist in a branch of forest science and who has some understanding of the environmental, ecological and economic aspects of forestry. The Wood Professor of Forest Science shall undertake research in and shall lecture and give instruction in forestry and promote its study in the University ("the Professorship").

2. The University receives with gratitude the sum of £750,000 from Audrey and Martin Wood to be held on the trusts declared in this regulation. Further money or property may be paid or transferred to the University to be held on the same trusts. The assets so held will be known as the Professor of Forest Science Fund ("the Fund").

3. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

4. The University shall (1) apply the income of the Permanent Endowment; and (2) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the salary and expenses of the holder of the Professorship and associated overheads.

5. The administration of the Fund, and the application of its income and expendable capital, shall be the responsibility of the Department of Plant Sciences.

6. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the head of the college specified in (2) of this clause is Vice-Chancellor, a person appointed by Council;

(2) the head of the college to which the professorship shall be for the time being allocated by Council under any regulation in that behalf, or if the head is unable or unwilling to act, a person appointed by the governing body of the college;

(3) a person appointed by the governing body of the college specified in (2) of this clause;

(4)-(5) two persons appointed by Council; and

(6)-(9) four persons appointed by the Mathematical, Physical and Life Sciences Board.

7. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

8. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund and the Professorship.

9. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

10. Regulations 2–5 and 7–12 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

11. Subject to regulation 12, Council may amend, repeal or add to these regulations but no amendment is valid if it would cause the Fund to:

(1) cease to be exclusively charitable according to the law of England and Wales; or

(2) be outside the objects of the University.

12. Any amendment to regulation 4 is an amendment to the main objects of the Fund and may only be made:

(1) by Council if more than 25 years have elapsed since the date of this regulation and the application of the Fund in accordance with regulation 4 has, in the University's reasonable opinion, ceased to provide a suitable and effective method of using the Fund, regard being had to the spirit of the original gift; or

(2) pursuant to Part D of Statute XVI with the approval of both Congregation of the University and subsequently Her Majesty in Council.

13. The professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.'

(1) Voting on change in Congregation Regulations: membership of Congregation

Explanatory Note

The following change affirms that staff who have transferred to the University under the Transfer of Undertakings (Protection of Employment) Regulations 2006 ('TUPE') and are on grades assessed as equivalent to grade 8 or above are eligible for Congregation membership.

Text of Regulations

In Congregation Regulations 1 of 2002, concerning membership of Congregation (Supplement (1) to *Gazette* No. 4633, 9 October 2002, p. 160, amended on 20 March 2007), delete existing paragraph (10) of regulation 1 and substitute (new wording underlined):

'(10) all persons working in any university department or institution who hold posts on, or assessed as equivalent to, grades 8 and above;'.

(2) Voting on Legislative Proposal: Statute V: Green Templeton College

The following legislative proposal replaces references to Green and Templeton Colleges in Statute V with a reference to Green Templeton College, following formal conclusion of the merger. If the Statute is approved, the existing regulations concerning Green College will no longer be required and will therefore be repealed.

WHEREAS it is expedient to amend the list of colleges recognised by the University to include Green Templeton College, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of Her Majesty in Council, AS FOLLOWS.

1 In section 1 of Statute V concerning Colleges, Societies, and Permanent Private Halls (Supplement (1) to *Gazette* No. 4633, 9 October 2002, approved with effect from 1 October 2002, as amended on 17 July 2003 and 12 October 2010, *Gazette*, Vol. 133, p. 1536; Vol. 141, p. 110, 14 October 2010), delete 'Templeton College' and insert 'Green Templeton College' after 'Exeter College'.

Repeal Council Regulations 9 of 2002 concerning Green College (made by Council on 26 June 2002, Supplement (2) to *Gazette* No. 4628).

(3) Voting on Legislative Proposal: Basant Kumar and Sarala Birla Graduate Scholarship Fund

Explanatory Note

The following legislative proposal clarifies that the scholarships may be awarded for study in any graduate programme in the Faculty of Linguistics, Philology and Phonetics, and provides the Faculty with flexibility to provide one or more partial awards in a given year.

WHEREAS it is expedient to change the existing provisions governing the Basant Kumar and Sarala Birla Graduate Scholarship Fund, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of Her Majesty in Council, AS FOLLOWS.

In the Schedule to the Statutes (Supplement (1) to *Gazette* No. 4633, 9 October 2002, pp. 133-59), after Part 71 insert the following new Part 72¹ (new text underlined, deleted text scored through):

'§ 200. <u>Part 72:</u> Basant Kumar and Sarala Birla Graduate Scholarship Fund

1. The benefaction from Birla International Limited of eight hundred and fifty one thousand pounds (£851,000), together with any further donations for this purpose, shall be known as the Basant Kumar and Sarala Birla Graduate Scholarship Fund for the Support of Graduate Study in Linguistics, Philology and Phonetics.

2. The University shall retain all of the Fund as permanent endowment and shall apply the net income of the Fund towards the Basant Kumar and Sarala Birla Graduate Scholarship in the Faculty of Linguistics, Philology and Phonetics.

3. The administration of the Fund, and the application of its income, shall be the responsibility of the Board of the Faculty of Linguistics, Philology and Phonetics.

4. The Scholarships shall be open to students from any country of residence who are undertaking graduate <u>study or</u> research <u>in Linguistics</u> in the Faculty of Linguistics, Philology and Phonetics. 5. <u>The Fund may be used to provide one</u> or more Scholarships in any year, Each Scholarship <u>may will</u> provide full funding for the standard duration of the student's course (typically three years in the case of doctoral students), <u>or may provide</u> <u>partial funding</u>. It is anticipated that one scholarship will be held at any one time.

6. The University will not offer a Scholarship until such time as the net income accumulates to the point where adequate funds become available to fund a student for the full duration of his/her course.

7<u>6</u>. Regulations 3, 4, and 5 and 6 may be amended by Council.'

Regulations to be made by Council if the Statute is approved by Her Majesty in Council

2 This regulation shall be effective from the date on which the Statute approved by Congregation on [date] is approved by Her Majesty in Council.

(4) Voting on Legislative Proposal: Women Students Fund

Explanatory Note

The following legislative proposal widens the objects of the trust fund such that it can be used for the benefit of all students studying in the Department of Education, rather than being restricted to female students only. As a consequence, the name of the trust is to be changed from 'Women Students Fund' to the 'Talbot Trust', which reflects the name of the donor.

WHEREAS it is expedient to change the existing provisions governing the Women Students Fund, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of Her Majesty in Council, AS FOLLOWS.

In the Schedule to the Statutes (Supplement (1) to *Gazette* No. 4633, 9 October 2002, pp. 133–59), after Part 71 insert the following new Part 73¹ (new text underlined, deleted text scored through):

'§ 388. Women Students Fund Part 73: Talbot Trust

1. The University accepts from the present trustees thereof the sum of approximately £37,000, which shall form a fund to be known as the Women Students Fund <u>Talbot</u> <u>Trust</u>. The said sum shall be held by the University on the trusts of the declaration of trust of 25 March 1933, namely for the benefit of the women students of the University.

2. The Committee for Educational Studies shall be the board of management for the fund.'

Regulations to be made by Council if the Statute is approved by Her Majesty in Council

2 This regulation shall be effective from the date on which the Statute approved by Congregation on [date] is approved by Her Majesty in Council.

(5) Voting on Legislative Proposal: Kelley Reader in Metallurgy

Explanatory Note

The following legislative proposal enables the funds from the Kelley Readership in Metallurgy trust to be used to support a new academic post, which will be known as the George Kelley Senior Research Fellowship in Materials. The fellow will be expected to undertake research and teaching in Materials which is in line with the current purpose of the trust.

WHEREAS it is expedient to change the existing provisions governing the Kelley Reader in Metallurgy, NOW THE UNIVERSITY OF OXFORD, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, ENACTS, subject to the approval of Her Majesty in Council, AS FOLLOWS.

In the Schedule to the Statutes (Supplement (1) to *Gazette* No. 4633, 9 October 2002, pp. 133–59), after Part 71 insert the following new Part 74¹ (new text underlined, deleted text scored through):

'§ 226. Kelley Reader in Metallurgy Part 74: George Kelley Senior Research Fellow in Materials

1. There shall be a George Kelley Senior Research Fellow in Materials who will be appointed by a committee appointed by the Department of Materials and who will undertake research and teaching in Materials.

¹The number is subject to the approval of other legislative proposals and may therefore change.

Notices

1. There shall be a George Kelley Reader in Metallurgy who shall be elected by a board consisting of:

(1) the Vice-Chancellor;

(2) the Head of the Department of Materials;

(3) a person appointed by Council;

(4) a person appointed by the General Board;

(5)-(7) three persons appointed by the Board of the Faculty of Physical Sciences.

2. The reader shall engage in advanced study or research and shall, under the direction of the Head of the Department of Materials, lecture and give instruction in Metallurgy in every term.

3. If at any time there is a vacancy in the readership, the emoluments shall be added to the capital endowment for the readership.

Regulations to be made by Council if the Statute is approved by Her Majesty in Council

2 This regulation shall be effective from the date on which the Statute approved by Congregation on [date] is approved by Her Majesty in Council.

(6) Voting on Resolutions authorising expenditure from the Higher Studies Fund

Text of Resolutions

(i) That the University be authorised to expend, from that part of the Higher Studies Fund earmarked for Social Studies, the sum of £81,148 over three years, to provide research support to Professor Fredman, Rhodes Professor in the Laws of the British Commonwealth and the United States.

(ii) That the University be authorised to expend, from that part of the Higher Studies Fund earmarked for Social Studies, the sum of £75,000 over three years, to provide research support to the inaugural Stanley Lewis Professor of Israel Studies.

General notices

Statute approved by Her Majesty in Council

Mr Vice-Chancellor has received a communication from the Clerk of Her Majesty's Privy Council, stating that on 12 October 2011 Her Majesty was pleased to approve the statutes amending Statute VI and making consequential changes to other statutes, printed in *Gazette*, Vol. 141, p. 400, 10 February 2011, and approved by Congregation on 22 February, p. 461. The statute concerning the quorum of Council shall be effective from **12 October 2011** and the statute concerning the removal of Council members shall be effective from **1 January 2012**.

Response to White Paper

The University submitted a response to the government's White Paper on higher education, *Students at the Heart of the System*, on 16 September. Comments were invited by the government through a consultation period which opened on 28 June and closed on 20 September. The University's approach to drafting the response over the long vacation, while the usual decision-making committee structure was not in operation, was set out in *Gazette*, Vol. 141, p. 790, 28 July 2011.

BIS's technical consultation on regulation of the higher education sector was launched on 4 August, with a closing date of 27 October. This considered the changes required to the legislative framework to implement the proposals in the White Paper. Drafts of the University's response to this consultation were considered by the Planning and Resource Allocation Committee, Education Committee and Council and the response was submitted by the deadline.
