General Purposes Committee of Council

The General Purposes Committee of Council has made the following changes in regulations, to come into effect on **12 November**.

(a) Wallis Professorship of Mathematics

Explanatory Note

The following changes, made on the recommendation of the Mathematical, Physical and Life Sciences Division and the Mathematical Institute, update outdated wording in the regulations.

Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships, amend the Wallis Professorship of Mathematics (new text underlined, deleted text struck through):

'Wallis Professor of Mathematics

1. The Wallis Professor of Mathematics shall <u>undertake research in and</u> shall lecture and give instruction in Mathematics, with special reference to analysis or mathematical probability, and shall generally promote its study in the University.

2. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the head of the college specified in (2) of this clause is Vice-Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;

(2) the head of the college to which the professorship shall be for the time being allocated by Council, or if the head is unable or unwilling to act, a person appointed by the governing body of the college on the occurrence of a vacancy to act as an elector on that occasion;

(3) a person appointed by the governing body of the college specified in (2) of this clause;

(4), (5) two persons appointed by Council;

(6) a person appointed by the Mathematical, Physical and Life Sciences Board;

(7)-(9) three persons appointed by the Departmental Committee of the Mathematical Institute.

3. The professor shall be subject to the General Provisions of the regulations governing the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.'

(b) Professorship of Computing

Explanatory Note

The following changes, made on the recommendation of the Mathematical, Physical and Life Sciences Division and the Department of Computer Science, make permanent a preexisting temporary naming of the post and update outdated wording and references in the regulations.

Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships, amend the Professorship of Computing (new text underlined, deleted text struck through):

^c<u>Christopher Strachey</u> Professor of Computing

1. The <u>Christopher Strachey</u> Professor of Computing shall <u>undertake research</u> <u>in and shall</u> lecture and give instruction in Computation<u>, and shall generally</u> <u>promote its study in the University</u>.

2. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the President of Wolfson College is Vice-Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;

(2) the President of Wolfson College, or, if the President is unable or

unwilling to act, a person appointed by the governing body of Wolfson College on the occurrence of a vacancy to act as an elector on that occasion;

(5), (6) <u>a</u> two persons appointed by the General Board; <u>Mathematical</u>, <u>Physical and Life Sciences Board</u>;

(7)-(9) three persons appointed by the Board of the Faculty of Mathematical Sciences, in consultation with the Sub-faculty of Computation <u>Department of</u> <u>Computer Science.</u>

3. The professor shall be subject to the General Provisions of the decreeregulations governing the duties of professors and to those Particular Provisions of the same decreeregulations which are applicable to this chair.'

(c) Sherardian Professorship of Botany

Explanatory Note

The following changes, made on the recommendation of the Mathematical, Physical and Life Sciences Division and the Department of Plant Sciences, update outdated wording in the regulations.

Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships, amend the Sherardian Professorship of Botany (new text underlined, deleted text struck through):

'Sherardian Professor of Botany

1. The Sherardian Professor of Botany shall undertake research in and shall lecture and give instruction in Botany, and shall generally promote its study in the University.

2. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the President of Magdalen College is Vice-Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;

(2) the President of Magdalen College, or if the President is unable or unwilling to act, a person appointed by the governing body of Magdalen College on the occurrence of a vacancy to act as an elector on that occasion;

(3) a person appointed by the governing body of Magdalen College;

(4), (5) two persons appointed by Council;

-(6)-(9) four persons appointed by the Life and Environmental Mathematical, Physical and Life Sciences Board;

3. The professor shall be subject to the General Provisions of the decree <u>regulations</u> governing the duties of professors and to those Particular Provisions of the same decree <u>regulations</u> which are applicable to this chair.'

(d) BT Professor of Major Programme Management

Explanatory Note

The following changes, made on the recommendation of the Social Sciences Division, update outdated wording in the regulations.

Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships, amend the BT Professor of Major Programme Management (new text underlined, deleted text struck through):

'1. The benefaction of £2.8m from BT PLC, together with any further donations for this purpose, shall be used to establish and maintain the BT Professorship of Major Programme Management. 2. The University shall apply the capital and net income towards the salary and expenses of the holder of the Professorship and associated overheads and outgoings, specifically any tax that may become levied in relation to the Professorship or any Centre with which the Professorship may be associated from time to time.

3. The administration of the benefaction, and the application of its capital and income, shall be the responsibility of the Executive Board of the Saïd Business School.

4. The BT Professor of Major Programme Management shall <u>undertake research</u>lecture and give instruction in management studies.

5. The professor shall be elected by an electoral board consisting of:

the Vice-Chancellor, or if the head of the college specified in paragraph-(2) below is the Vice-Chancellor, a person appointed by Council;

(2) the head of the college to which the Chair may be allocated by Council from time to time; or if the head is unable to unwilling to act, a person appointed by the governing body of that college;

(3) a person appointed by the governing body of the college;

(4), (5) two persons appointed by Council;

(6) a person appointed by the Social Sciences Board; and

(7)-(9) three persons appointed by the Saïd Business School.

6. The professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations, which are applicable to the Chair.

7. Regulations 1-2 shall be deemed as Trust Regulations under the provisions of Part D of Statute XVI.

8. Regulations 3-6 may be amended by Council.

(e) White's Professor of Moral Philosophy

Explanatory Note

These changes are made to formalise the trust created by the receipt of the gifts from Thomas White and the Sekyra Foundation.

Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships, amend the section concerning the White's Professor of Moral Philosophy as follows (new text underlined, deleted text struck through):

'White's Professor of Moral PhilosophyWhite's Estate Fund

1. The University receives with gratitude gifts to be held as permanent endowment and gifts to be held as expendable endowment on the trusts. declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the White's Estate Fund ("the Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment: and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the salary and expenses of the holder of a chair of moral philosophy ("the Chair") and associated overheads.

+4. The holder of the Chair shall be known as the Sekyra and White's Professor of Moral Philosophy <u>("the</u> <u>Professor"). The Professor</u> shall lecture and give instruction <u>undertake research</u> and teaching in Philosophy with special regard to the Problems, Theories, and History of Ethics. 5. If the salary, expenses and overheads of the Professor are wholly or partly covered from other sources or there are further funds available, there shall be discretion to apply the income of the Fund to support the Professor's research.

6. The administration of the Fund, and the application of its income, shall be the responsibility of the Humanities Divisional Board.

27.The **Pp**rofessor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the President of Corpus Christi College is Vice Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;

(2) the President of Corpus Christi College, or, if the President is unable or unwilling to act, a person appointed by the Governing Body of Corpus Christi College;

(3) a person appointed by the Governing Body of Corpus Christi College;

(4), (5) two persons appointed by Council;

(6) the Head of the Humanities Division, or his or her nominee;

(7)-(9) three persons elected by the Board of the Faculty of Philosophy.

38. The Pprofessor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this <u>Gehair</u>. They shall give not less than thirtysix lectures or classes in the year, provided that this obligation may be reduced in exceptional circumstances with the approval of the faculty board concerned.

9. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. 10. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Chair.

11. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.

12. Regulations 1-6 and 8-13 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

<u>13. Subject to regulation 14. Council</u> <u>may amend, repeal or add to these</u> <u>regulations in accordance with Part D of</u> <u>Statute XVI, but no amendment is valid</u> <u>if it would cause the Fund to:</u>

(1) cease to be exclusively charitable according to the law of England and Wales: or

(2) be outside the objects of the University.

14. Any amendment to regulation 3 is an amendment to the main objects. of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

(f) Robert Turner Professor of Diabetic Medicine

Explanatory Note

These changes are made to formalise the trust created by the receipt of the gift from Les Laboratoires Servier.

Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships,

amend the section concerning the Robert Turner Professor of Diabetic Medicine as follows (new text underlined, deleted text struck through):

'Robert Turner Professor of Diabetic Medicine <u>(Servier) Fund</u>

1. The University receives with gratitude the sum of £2,350,000 from Les Laboratoires Servier to be held as permanent endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Robert. Turner Professor of Diabetic Medicine (Servier) Fund ("the Fund").

2. The University shall retain as permanent endowment those. of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment; and (b) apply the income and, in its discretion, the capital of the remainder of the Fund for the advancement of education for the benefit of the public by establishing and maintaining a post that shall be called the Robert Turner Professor of Diabetic Medicine ("the Professor").

14. The Robert Turner Professor of Diabetic Medicine shall undertake research in Diabetes and shall lecture and give instruction in this subject activities, including any of the following: diabetic research, the practice of clinical diabetes, lectures and the giving of instruction in diabetes.

5. The Fund shall be used to pay the salary and expenses of the Professor and associated overheads. If the salary, expenses and overheads of the Professor are wholly or partly covered from other sources or there are further funds available, there shall be discretion to apply the income of the Fund to support the Professor's research: to make acquisitions of items to support the work of the Professor; or to support the work of the Professor in any other manner.

26. The <u>P</u>professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the head of the college specified in (2) of this clause is Vice-Chancellor, a person appointed by Council;

(2) the head of the college to which the professorship shall be for the time being allocated by Council under any decree in that behalf, or, if the head is unable or unwilling to act, a person appointed by the governing body of the college;

(3) a person appointed by the governing body of the college specified in (2) of this clause;

(4), (5) two persons appointed by Council;

(6)-(9) four persons appointed by the Medical Sciences Board;

(10) a person holding a clinical appointment appointed by the relevant NHS body with which the post-holder will hold an honorary contract.

37. The <u>Pp</u>rofessor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.

8. The University shall have power to pay out of the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund and the post.

9. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations. 10. Regulations 1-5 and 7-12 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

11. Subject to regulation 12, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

(1) cease to be exclusively charitable according to the law of England and Wales; or

(2) be outside the objects of the University.

12. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

(g) Radhakrishnan Memorial Bequest

Explanatory Note

These changes amend the regulations for the Radhakrishnan Memorial Bequest to include updates to the board of management, wording and content of the regulations.

Text of Regulations

In Council Regulations 25 of 2002, concerning trusts, amend the Radhakrishnan Memorial Bequest as follows (new text underlined, deleted text struck through):

'Radhakrishnan Memorial Bequest

1. The University accepts with gratitude the sum of £50,000 from the estate of the late Professor Sir Sarvepalli Radhakrishnan to be held as permanent endowment on the trusts declared in this regulation. Further money property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as which shall form a fund to be called the Radhakrishnan Memorial Bequest (<u>"the Fund"</u>). 2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment: and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, to enable a scholar to visit the University to give a series of lectures in some field of Indian Studies.

24. There shall be a board of management of the bequest composed of the following persons:

(1) the Vice-Chancellor;

(2) Dr S. Gopal during his life-time;

(23) the Spalding Professor of Eastern Religions and Ethics;

(34) the Warden of All Souls;

(45) the Chairman of the Interfaculty Committee for South Asian Studies.:

(5), (6) two persons appointed by the Board of the Faculty of Oriental Studies.

The board of management shall have power to co-opt up to twothree additional members for periods of five years for such periods as the board sees fit.

3. There shall be an electoral board, comprising: (1) the Vice Chancellor; (2), (3) two members of the board of management appointed by the board; (4) Dr S. Gopal during his life-time, and thereafter a third member of the board of management appointed by the board.

45. The electoral board <u>of management</u> shall at least in every other year elect a scholar, with a preference for scholars from outside Oxford, to visit the University either in Michaelmas or Hilary or Trinity Term (but not in more than one) to give a series of lectures in some field of Indian Studies. <u>56</u>. The <u>lecturerscholar</u> shall be known as the Radhakrishnan Memorial Lecturer.

67. The board of management shall fix the amounts of the <u>Radhakrishnan</u> <u>Memorial L</u>^lecturer's emoluments and expenses, which shall be paid from the income of the Radhakrishnan Memorial Bequest.

78. Any income not used to pay the emoluments and expenses of the Radhakrishnan Memorial Lecturer may at the discretion of the board of management be:

(a) carried forward for use in a subsequent year;

(b) applied to assist students who are citizens of <u>ordinarily</u> resident in the Republic of India and who are studying, or wish to study, in Oxford;

(c) applied in any other way which the board shall think conducive to the promotion of Indian Studies in the University of Oxford.

9. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

'The Bern and Ronny Schwartz Curator of Photography Fund

1. The University receives with gratitude the sum of £2,000,000 from the Bern Schwartz Family Foundation to be held as permanent endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as The Bern and Ronny Schwartz Curator of Photography Fund ("the Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment"). 3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund for the advancement of education for the benefit of the public by establishing and maintaining a post that shall be called The Bern and Ronny Schwartz Curator of Photography.

4. The Curator shall be responsible for acquiring, managing, and ensuring the preservation of photographic collections at the Bodleian Libraries, and for supporting teaching, research and public engagement using those collections.

8. The administration of the Fund, and the application of its income, shall be the responsibility of Bodley's Librarian, subject to oversight by the Curators of the University Libraries.

9. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

10. The University shall have power to pay out of the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund and the post.

'Berrow Foundation Lord Florey Associate Professor Tutorial Fellow in Biochemistry Fund

1. The University receives with gratitude the sum of £1,700,000 from the Edward Penley Abraham Research Fund to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Berrow Foundation Lord Florey Associate Professor Tutorial Fellow in Biochemistry Fund ("the Fund").

2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").

3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund for the advancement of education for the benefit of the public by establishing and maintaining a post that shall be called the Berrow Foundation Lord Florey Associate Professor Tutorial Fellow in Biochemistry ("the Associate Professor").

4. The Associate Professor shall lecture, teach and undertake research in the field of Biochemistry.

The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

8. The University shall have power to pay out of the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund and the post.
