Text of Regulations

1. The Professor of Environment and Public Policy Environmental Geography shall undertake research in Environment and Public Policy and shall lecture and give instruction in that subject.'

(b) Halford Mackinder Professor of Geography

Explanatory Note

The change in name is proposed to better reflect the values of the School of Geography and the Environment and its academic community. 1971 is the year in which this post was established.

Text of Regulations

Congregation 11 February

Voting on Resolution approving the Conferment of a Degree by Diploma

Explanatory Note

By longstanding tradition, the University has conferred by diploma upon the Chancellor-elect the Degree of Doctor of Civil Law (unless, of course, the Chancellor-elect already holds that degree, otherwise than *honoris causa*). Council is in no doubt that it would be appropriate to continue this tradition and accordingly seeks the approval of Congregation for the following resolution.

Text of Resolution

That the conferment of the Degree of Doctor of Civil Law by Diploma upon the **Rt Hon William Jefferson Hague**, Baron Hague of Richmond, PC, FRSL, MA, Honorary Fellow of Magdalen, Chancellor-elect of the University, be approved. If the resolution is approved, the degree will be conferred as part of the ceremony on 19 February to admit Lord Hague to the office of Chancellor.

(a) Voting on a Resolution authorising the allocation of space in the Alden Press Annexe to Gardens, Libraries and Museums

The following resolution will be deemed to be approved at **noon on 25 February**, unless by that time the Registrar has received notice in writing from two or more members of Congregation that they wish the resolution to be put to a meeting of Congregation.

Explanatory Note

Gardens, Libraries and Museums (GLAM) occupies approximately 825 sqm within the Alden Press Annexe, which provides essential storage for museum collections, heritage furniture and museum display equipment. The Alden Press Annexe will be required until completion of an additional storage chamber at Swindon Collections Storage Facility (building 383) anticipated for completion in January 2026, with subsequent relocations complete by the end of December 2026.

Text of Resolution

That approximately 825 sqm net usable area within Alden Press Annexe (building 848) be allocated to Gardens, Libraries and Museums, for occupation by the Ashmolean Museum, the Museum of Natural History, the Pitt Rivers Museum, and the History of Science Museum, for a further period of approximately 2.5 years, backdated to 1 October 2024, to expire 30 March 2027, or until the site is required as part of the wider redevelopment of Osney Mead or the transfer of museums' items in alternative long-term storage, if sooner.

(b) Voting on a Resolution to constitute a Redundancy Panel under Statute XII: Academic Staff and the Visitatorial Board

Explanatory Note

The first four stages of the Redundancy Procedure have been undertaken following a proposed restructure. The proposed re-structure resulted in changes to a role description, which amended the duties and complexity of the role, and the line management. Job evaluation was carried out which resulted in the down-grading of the role from a grade 6 to a grade 5. One individual was warned that they were at risk of redundancy, two others were consulted due to changes in line management responsibilities. The at risk individual was consulted with between January and April 2024. It has not been possible to agree either voluntary redundancy or redeployment despite an extended period of consultation (April–September 2024).

In the absence of agreement to redeployment or voluntary redundancy, the agreement of Congregation is sought under Part B, Section 13 of Statute XII to constitute a Redundancy Panel in respect of one individual, in accordance with the regulations governing the membership of panels convened under Parts B, D and H of Statute XII. The role of the panel will be to scrutinise the proposal for redundancy, recommend

the member staff (if it considers it appropriate to do so) for dismissal by reason of redundancy, and report its recommendations to the relevant Divisional Board or equivalent. The Union has been informed. The member of staff whose post is under consideration is in a post which comes under the jurisdiction of Statute XII is in a G6 professional services support role in UAS.

Text of Resolution

That a Redundancy Panel be constituted to consider whether to recommend dismissal by reason of redundancy in respect of one member of staff who is in a G6 professional services support role in UAS.

When required, places will be allocated according to academic standing, as defined in Council Regulations 22 of 2002, Part 2: Academic Precedence and Standing. If the number of nominations received by the closing date is less than sufficient to fill the vacancies, those candidates nominated will be deemed elected unopposed, and the remaining vacancies will lapse, in which case, in accordance with the regulations, the places must remain vacant until appointments are made jointly by the Vice-Chancellor and Proctors.

Period of office

All vacancies are with immediate effect unless otherwise stated. In accordance with Congregation Regulations 2 of 2002, in any election where vacancies are to be filled for periods of different length, the elected candidates shall hold office so that the tenure of those who receive more votes shall be longer than that of those who receive fewer votes; but if the election is uncontested or if two candidates receive the same number of votes, the candidate senior in academic standing shall hold office for the longer period.
