#### **General Purposes Committee of Council**

The General Purposes Committee of Council has made the following changes to regulations, to come into effect on **15 November**, unless notice of a resolution calling

# upon Council to annul or amend the regulation is received by the Registrar by **noon on 11 November** (as set out in Statute VI: Council).

#### (a) Professorship of Informatics

#### **Explanatory Note**

The following changes, made on the recommendation of the Mathematical, Physical and Life Sciences Division and the Department of Computer Science, adjust the title of the Professorship to harmonise with terminology used at the University and update outdated wording in the regulations.

#### Text of Regulations

In <u>Council Regulations 24 of 2002</u>, concerning individual professorships, amend the Professorship of Informatics as follows (new text underlined, deleted text struck through):

'Professor of Informatics Computer Science

1. There shall be a Professor of Informatics Computer Science, who shall undertake research in and shall lecture and give instruction in that subject and generally promote its study in the University.

- 2. The professor shall be elected by an electoral board consisting of:
  - (1) the Vice-Chancellor, or, if the head of the college specified in (2) of this clause is Vice-Chancellor, aperson appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;
  - (2) the head of the college to which the professorship shall be for the time being allocated by Council under any regulation in that behalf, or, if the head is unable or unwilling to act, a person appointed by the governing body of the college on the occurrence of a vacancy to act as an elector on that occasion;

#### (b) Cancer Research UK Professor of Medical Oncology

#### **Explanatory Note**

These changes in regulations are made to clarify that the postholder is expected to carry out research. The opportunity is taken to add full trust regulations which clearly state the University's obligations and powers, and identify a board of management as required in <a href="Statute">Statute</a> XVI.

#### Text of Regulations

In <u>Council Regulations 24 of 2002</u>, concerning individual professorships, amend the Cancer Research UK Professor Medical Oncology as follows (new text underlined, deleted text struck through):

'1. The University accepts with deep gratitude the permanent endowment provided by the Imperial Cancer Research Fund to be held on the trusts declared in this regulation Cancer Research UK for the establishment of a Cancer Research UK Professorship of Medical Oncology and for the provision of supporting expenditure for the professorship. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Cancer Research UK Professor of Medical Oncology Fund ("the Fund").

- 2. The University shall retain as permanent endowment those of the assets of the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 3. The University shall (a) apply the income of the Permanent Endowment; and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, to the establishment and maintenance of the post of Cancer Research UK Professor of Medical Oncology ("the professor") and the provision of supporting expenditure for that post. The first call on the fund shall be the salary and expenses of the Professor and associated overheads.
- 4. The administration of the Fund, and the application of its income shall be the responsibility of the Medical Sciences Board.
- <u>5. 2.</u> The professor shall be elected by an electoral board consisting of:
  - (1) the Vice-Chancellor, <u>or their nominee</u> or, <u>if the head</u> of the college specified in paragraph (2) below is Vice-Chancellor, a person appointed by Council;

- (2) the head of the college to which the professorship shall be for the time being allocated by Council under any regulation in that behalf, or, if the head is unable or unwilling to act, a person appointed by the governing body of the college;
- (3) a person appointed by the governing body of the college specified in paragraph (2) above;
- (4), (5) two persons appointed by Council, one appointed in agreement with Cancer Research UK;
- (6)–(9) four persons appointed by the Medical Sciences Board;
- (10) a person appointed by the body or bodies which may issue an honorary clinical contract or contracts to the professor.

At least three members of the board, of whom one shall be a professor, shall hold clinical appointments.

- <u>6. 3.</u> The professor shall hold <u>their his or her</u> appointment in a department to be designated from time to time by the Medical Sciences Board in agreement with Cancer Research UK. The professor shall <u>undertake research</u>, lecture and give instruction in Medical Oncology.
- 7.4. The professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.

- 5. Such part of the endowment as Council shall determine is not required to meet the costs of the professorship shall be applied to the provision of supporting expenditure for the professor in such manner as Council, after consultation with the Medical Sciences Board, shall direct.
- 8. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund and the Scholarship/Professorship.
- 9. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 10. Regulations 1-4 and 8-12 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.
- 11. Subject to regulation 12 and the consent of Cancer Research UK, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 12. Any amendment to the main objects of the Fund for the purposes of Part D of Statute XVI, as set out in regulation 3, and must be approved both by Congregation of the University and subsequently by His Majesty in Council.'

#### (c) Rhodes Professor of Experimental Therapeutics and Clinical Pharmacology

#### Explanatory Note

The following changes have been made to update outdated references.

#### Text of Regulations

In <u>Council Regulations 24 of 2002</u>, concerning individual professorships, amend the Rhodes Professorship of Experimental Therapeutics and Clinical Pharmacology as follows (new text underlined, deleted text struck through):

- 'Rhodes Professor of Experimental Therapeutics and Clinical Pharmacology
- 1. The Rhodes Professor of Experimental Therapeutics and Clinical Pharmacology shall undertake research in Experimental Therapeutics and Clinical Pharmacology and shall lecture and give instruction in this subject.

- 2. The professor shall be elected by an electoral board consisting of:
- (1) the Vice-Chancellor<del>, or, if the head of the college specified in (2) of this clause is Vice-Chancellor, a person appointed by Council</del>;
- (2) the head of the college to which the Chair may be allocated by Council from time to time; or, if the head is unable or unwilling to act, a person appointed by the governing body of that college;
- (3) a person appointed by the governing body of the college specified in (2) of this clause;'

...'

#### (d) Regulations for the McCord Professor of Philosophy and Artificial Intelligence Fund

#### **Explanatory Note**

These new regulations are made to formalise the trust created by the receipt of the gift from the Cosmos Institute INC.

#### Text of Regulations

In <u>Council Regulations 25 of 2002</u>, concerning Trusts, insert:

## 'McCord Professor of Philosophy and Artificial Intelligence Fund

- 1. The University receives with gratitude gifts from the Cosmos Institute, INC. to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the McCord Professor of Philosophy and Artificial Intelligence Fund ("the Fund").
- 2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the salary and expenses of the holder of the McCord Professor of Philosophy and Artificial Intelligence ("the Professor") and associated overheads. The Professor shall undertake research, lecture and give instruction in the fields of philosophy, cognitive science and artificial intelligence. If the salary, expenses and overheads of the Professor are wholly or partly covered from other sources or there are further funds available, there shall be discretion to apply the income and/or capital of the Fund to support the Professor's research and research programmes.
- 4. The administration of the Fund, and the application of its income, shall be the responsibility of the Humanities Board.

- 5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.
- 6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, the management and administration of the Fund and the Professor.
- 7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 8. The Professor shall be subject to the General Provisions of the regulations concerning the duties of Professors and to those Particular Provisions of the same regulations which are applicable to this post.
- 9. These regulations shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.
- 10. Subject to regulation 11, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 11. Any amendment to the main objects of the Fund for the purposes of Part D of Statute XVI, as set out in regulation 3, must be approved both by Congregation of the University and subsequently by His Majesty in Council.'

#### (e) Regulations for the Department of Education Graduate Support Fund

#### **Explanatory Note**

These new regulations are made to formalise the trust created by the receipt of the gift from Doreen Bailey.

#### Text of Regulations

In <u>Council Regulations 25 of 2002</u>, concerning Trusts, insert:

#### 'Department of Education Graduate Support Fund

- 1. The University receives with gratitude gifts from Doreen Bailey to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Department of Education Graduate Support Fund ("the Fund").
- 2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards making financial awards to support practicing graduate educators and educational researchers.
- 4. The administration of the Fund, and the application of its income, shall be the responsibility of the Social Sciences Board.
- 5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation,

instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

- 6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund.
- 7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 8. These regulations shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

#### Call for nominations for Honorary Degrees and for Degrees by Diploma

The Committee on Honorary Degrees is seeking honorary degree nominations. Nominations can be made by current members of staff and students via the online form: https://forms.office.com/e/u1kmkyKYmR.

When considering possible honorands, the Honorary Degrees Committee will focus on individuals:

- of high academic distinction in the fields of research and scholarship of specific interest to the University of Oxford;
- distinguished in the visual, literary, musical, and performing arts or in sports;
- · distinguished in business and industry;
- who have played a distinguished role in public life, for example in contributing to progress and change in society;
- who have made a significant contribution to the activities of the University of Oxford—such individuals would normally also fall into one of the categories above.

Within those categories, the Honorary Degrees Committee will aim to produce a balanced list, which takes account of the global dimension that characterises this University's activities.

When a degree is conferred upon a royal personage or upon the head of a foreign state it will be conferred by diploma.

The Honorary Degrees Committee has adopted a target that half of the final list of names proposed for the conferment of honorary degrees be women and/or from minoritised groups. Nominators are therefore

encouraged to propose individuals of conspicuous distinction with particular reference to diversity.

Honorary degrees will not be conferred on anyone who holds, or who has retired from, a resident teaching, research or administrative post within the University or in any college or other society, except in exceptional circumstances such as distinguished service outside the terms of his or her paid service. In these circumstances, a proposal for an honorary MA may be put forward.

While informal soundings within the University will often be desirable, every effort should be made to ensure that publicity is not at any stage given to any specific proposal for the conferral of an honorary degree. All nominations will be considered in strict confidence by the committee.

A Convocation will take place during Week 3 of Michaelmas term (week commencing 28 October) for the purpose of electing a Chancellor. The election will be conducted in accordance with the provisions of Council

#### **VOTING ARRANGEMENTS**

The election will be held online only and administered by Civica. As outlined on the Chancellor's election webpage (<a href="www.ox.ac.uk/about/organisation/university-officers/chancellor/chancellor-election">www.ox.ac.uk/about/organisation/university-officers/chancellor/chancellor-election</a>), the Alternative Vote system will be used, whereby voters can rank as many of the candidates as they choose. Lower-ranking candidates will be eliminated until 5 candidates remain.

#### THE CHANCELLORSHIP

Statutory provision

Statute IX, sections 2-5, provides as follows.

Regulations 8 of 2002 (<u>Gazette No 5421</u>, pp440–1); these regulations are available on the University website at: <a href="https://governance.admin.ox.ac.uk/legislation/council-regulations-8-of-2002">https://governance.admin.ox.ac.uk/legislation/council-regulations-8-of-2002</a>.

These 5 candidates will go forward to a second round, to take place during Week 6 of Michaelmas term.

The new Chancellor will be announced during Week 7 (week commencing 25 November). Registered voters will receive emails directly from Civica with a link to cast their vote for both of these rounds.

'2. The Chancellor shall be elected by Convocation and shall hold office for a fixed period decided by Council or until their resignation.

- 3. There shall be a Chancellor's Court of Benefactors to membership of which the Chancellor may from time to time admit major benefactors of the University.
- 4. The Chancellor shall have such other functions and powers as are assigned to them by the statutes and regulations or by the law of the land.

5. In the event of the incapacity or absence abroad of the Chancellor, or during a vacancy in the Chancellorship, or on delegation from the Chancellor, the Vice-Chancellor may exercise any of the functions and powers of the Chancellor, except where the statutes provide otherwise.'

#### STATEMENT ON THE CHARACTERISTICS OF A CHANCELLOR

#### For the guidance of candidates and electors

The Chancellor is the ceremonial head of the University of Oxford. While this key role has no executive responsibilities, it is more than symbolic; the Chancellor provides supportive and useful advice and guidance to the University, particularly to the Vice-Chancellor. The Chancellor presides at events such as Encaenia and at the Chancellor's Court of Benefactors and is sometimes expected to take a leading role at other official events. The Chancellor is the Visitor (an external figure of authority on whom the college can call for advice and for arbitration if insoluble dispute arises among its governing body) of five colleges and also chairs the Committee for the Nomination of the Vice-Chancellor. In addition to these formal duties, the Chancellor undertakes advocacy, advisory and fundraising work, acting as an ambassador for the University at a range of local, national and international events. The Chancellor

must be readily accessible and available throughout the year.

The University is seeking a candidate who can demonstrate:

- 1. outstanding achievements in their field and the ability to command respect beyond it;
- 2. a deep appreciation for the University's research and academic mission, its global community, and its ambition to remain a world-class research and teaching university;
- the ability and willingness to enhance the reputation of the University locally, nationally and abroad.

#### **CANDIDATE LIST**

Candidates have been considered by the Chancellor's Election Committee solely against the specific exclusion criteria as laid out in Part 7 of Council Regulations 8 of 2002, with no subjective selection process.
