# General Purposes Committee of Council

The General Purposes Committee of Council has made the following changes to regulations, to come into effect on **18 March**.

# (a) Professorship of Statistical Science

**Explanatory Note** 

The following changes, made on the recommendation of the Mathematical, Physical and Life Sciences Division and the Department of Statistics, update outdated wording in the regulations.

# Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships, amend the Professorship of Statistical Science (new text underlined, deleted text struck through):

# 'Professor of Statistical Science

- 1. The Professor of Statistical Science shall undertake research in and shall lecture and give instruction in Statistical Science, and shall generally promote the study of that subject in the Uuniversity.
- 2. The professor shall be elected by an electoral board consisting of:
  - (1) the Vice-Chancellor, or, if the President of St Anne's Gollege is Vice Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;
  - (2) the Principal of St Anne's College, or if the Principal is unable or unwilling to act, a person appointed by the governing body of St Anne's College on the occurrence of a vacancy to act as an elector on that occasion;
  - (3) a person appointed by the governing body body of St Anne's College;
  - (4)<u>. (5)</u> atwo persons appointed by Council;

- (5), (6) atwo persons appointed by the General Mathematical, Physical and Life Sciences Board;
- (7)-(9) three persons appointed by the <del>Board of the Faculty of</del> <del>Mathematical Sciences</del> <u>Department</u> of Statistics.
- 3. The professor shall be subject to the General Provisions of the decreeregulations governing the duties of professors and to those Particular Provisions of the same decreeregulations which are applicable to this chair.'

# (b) Sherardian Professorship of Botany

Explanatory Note

The following changes, made on the recommendation of the Mathematical, Physical and Life Sciences Division and the Department of Plant Sciences, update outdated wording in the regulations.

# Text of Regulations

In Council Regulations 24 of 2002, concerning individual professorships, amend the Sherardian Professorship of Botany (new text underlined, deleted text struck through):

# 'Sherardian Professor of Botany

- The Sherardian Professor of Botany shall undertake research in and shall lecture and give instruction in <u>Plant</u>. <u>Sciences</u><del>Botany</del>, and shall generally promote its study in the University.
- 2. The professor shall be elected by an electoral board consisting of:
  - (1) the Vice-Chancellor;
  - (2) the President of Magdalen College, or if the President is unable or unwilling to act, a person appointed by the governing body of Magdalen College on the occurrence of a vacancy to act as an elector on that occasion;
  - (3) a person appointed by the governing body body of Magdalen College:

- (4), (5) two persons appointed by Council;
- (6)-(9) four persons appointed by the Mathematical, Physical and Life Sciences Board:
- 3. The professor shall be subject to the General Provisions of the regulations governing the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.'

# (c) Establishment of the Primary Care Research Trust Mercian Chair of Primary Care

**Explanatory Note** 

These changes, made on the recommendation of the Medical Sciences Board, establish a new professorship of primary care.

Text of Regulations

- 'Primary Care Research Trust Mercian Chair of Primary Care'
- 2 In Council Regulations 24 of 2002, concerning individual professorships, insert:

# 'Primary Care Research Trust Mercian Chair of Primary Care

- 1. The Primary Care Research Trust Mercian Chair of Primary Care shall undertake research in primary care and shall lecture and give instruction in this subject.
- 2. The professor shall be elected by an electoral board consisting of:
  - (1) the Vice-Chancellor;
  - (2) the head of the college to which the professorship may be allocated by Council from time to time; or if the head is unable or unwilling to act, a person appointed by the governing body of that college;
  - (3) a person appointed by the governing body of the college specified in paragraph (2) above;
  - (4), (5) two persons appointed by Council;
  - (6)-(9) four persons appointed by the Medical Sciences Board;
  - (10) a person holding a clinical appointment appointed by the relevant NHS body with which the

post-holder will hold an honorary contract.

3. The professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.'

# (d) Establishment of the Poonawalla Professor of Biotechnology Fund

These new regulations are made to formalise the trust created by the receipt of the gift from the Natasha and Adar Poonawalla Foundation.

Text of Regulations

- 1 In the Schedule of Statutory Professorships annexed to Council Regulations 3 of 2004, insert:
- 'Poonawalla Professor of Biotechnology'
- 2 In Council Regulations 24 of 2002, concerning individual professorships, insert:

# 'The Poonawalla Professor of Biotechnology Fund

- 1. The University receives with gratitude funds from the Natasha and Adar Poonawalla Foundation to be held as expendable endowment on the trust declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trust. The assets so held will be known as the Poonawalla Professor of Biotechnology Fund ("the Fund").
- 2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund for the advancement of education for the benefit of the public by establishing and maintaining the post of Poonawalla Professor of Biotechnology ("the Professor").
- 4. The Professor shall undertake research and teaching in vaccinology and related disciplines.

- 5. The Fund shall be used to pay the salary and expenses of the Professor and associated overheads. If the salary, expenses and overheads of the Professor are wholly or partly covered from other sources or there are further funds available, there shall be discretion to apply the income of the Fund to support the Professor's research, provided that the subject matter of such research is in the field of medical sciences and therefore furthers the charitable purposes of the University and the Foundation; to make acquisitions of items to support the work of the Professor; or to support the work of the Professor in any other
- 6. The professor shall be elected by an electoral board consisting of:
  - (1) the Vice-Chancellor;
  - (2) the head of the college to which the professorship may be allocated by Council from time to time; or if the head is unable or unwilling to act, a person appointed by the governing body of that college;
  - (3) a person appointed by the governing body of the college specified in paragraph (2) above;
  - (4), (5) two persons appointed by Council;
  - (6)-(9) four persons appointed by the Medical Sciences Board.
- 7. The Professor shall be subject to the General Provisions of the regulations concerning the duties of Professors and to those Particular Provisions of the same regulations which are applicable to this post.
- 8. The administration of the Fund, and the application of its income, shall be the responsibility of the Medical Sciences Divisional Board.
- 9. The University may in its absolute discretion in the period ending 21 years from 14 December 2021, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.

- 10. The University shall have power to pay out of the income of the Fund all costs of and incidental to the creation of the Fund and the management and administration of the Fund and the post.
- 11. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 12. Regulations 1-5 and 8-14 shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.
- 13. Subject to regulation 14, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 14. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

# (e) Establishment of the Dieter Schwarz Associate Professorship in Artificial Intelligence, Government and Policy Fund and the Dieter Schwarz Associate Professorship in Artificial Intelligence and Work Fund

Explanatory Note

These new regulations are made to formalise the trusts created by the receipt of the gift from the Dieter Schwarz Foundation.

Text of Regulations

In Council Regulations 25 of 2002, concerning trusts, insert:

# 'The Dieter Schwarz Associate Professorship in Artificial Intelligence, Government and Policy Fund and the Dieter Schwarz Associate Professorship in Artificial Intelligence and Work Fund

1. The University receives with gratitude funds from the Dieter Schwarz Foundation to be held as expendable endowment on the trusts declared in this regulation. Further money or property may be paid or

transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Dieter Schwarz Associate Professorship in Artificial Intelligence, Government and Policy Fund ("the First Fund") and the Dieter Schwarz Associate Professorship in Artificial Intelligence and Work Fund ("the Second Fund").

- 2. The University shall retain as permanent endowment those of the assets in the Funds which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 3. The University shall (a) apply the income of the Permanent Endowments (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Funds for the advancement of education for the benefit of the public as follows:
  - (1) for the First Fund, by establishing and maintaining the post of Dieter Schwarz Associate Professorship in Artificial Intelligence, Government and Policy ("the First Associate Professor"); and
  - (2) for the Second Fund, by establishing and maintaining the post of Dieter Schwarz Associate Professorship in Artificial Intelligence and Work ("the Second Associate Professor").
- 4. (1) The first Associate Professor shall undertake research and teaching on topics relating to artificial intelligence, government and policy.
  - (2) The second Associate Professor shall undertake research and teaching on topics relating to technology, society, artificial intelligence and work.
- 5. Each Fund shall be used to pay the salary and expenses of the appropriate Associate Professor and associated overheads. If the salary, expenses and overheads of the Associate Professor are wholly or partly covered from other sources or there are further funds available, there shall be discretion to apply the income of each Fund to support the Associate Professor's research; to make acquisitions of items to support the work of the Associate Professor; or to support the work of the Associate Professor in any other manner.

- 6. The Associate Professors shall be subject to the General Provisions of the regulations concerning the duties of Associate Professors and to those Particular Provisions of the same regulations which are applicable to this post.
- 7. The administration of the Funds, and the application of their income, shall be the responsibility of the Social Sciences Divisional Board.
- 8. The University shall have power to pay out of the income of the Funds all costs of and incidental to the creation of the Funds and the management and administration of the Funds and the post.
- 9. The University may exercise any of its corporate powers in the management and administration of the Funds in so far as those powers are not inconsistent with these regulations.
- 10. These regulations shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.
- 11. Subject to regulation 12, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:
  - (1) cease to be exclusively charitable according to the law of England and Wales; or
  - (2) be outside the objects of the University.
- 12. Any amendment to regulation 3 is an amendment to the main objects of the Funds for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

# (f) Establishment of the Phillips Scholarship Fund

Explanatory Note

These new regulations are made to formalise the trust created by the receipt of the gift from David Phillips.

Text of Regulations

In Council Regulations 25 of 2002, concerning trusts, insert the following:

# 'Phillips Scholarships

1. The University receives with gratitude a gift from David Phillips to be held as an expendable endowment on the trusts declared in this regulation.

- Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Phillips Scholarships ("the Fund").
- 2. The University shall retain as permanent endowment those of the assets in the Fund (if any) which are contributed on the express understanding that they are to be treated as permanent endowment ("the Permanent Endowment").
- 3. The University shall (a) apply the income of the Permanent Endowment (if any); and (b) apply the income and, in its discretion, the capital of the remainder of the Fund to provide scholarships, to be called the Phillips Scholarships, which shall be available to graduate students commencing a DPhil course of study at the University, in one of the following fields: vaccinology, drug development, infectious diseases. emerging pathogens and global health. Preference shall be given to students undertaking such study within the Jenner Institute of the University's Nuffield Department of Medicine.
- 4. The administration of the Fund, and the application of its income, shall be the responsibility of the Nuffield Department of Medicine.
- 5. The University may in its absolute discretion in the period ending 21 years from the date of this regulation, instead of applying the income of the Fund in any year, accumulate all or any part of such income by investing it, and holding it as part of the capital of the Fund. The University may apply the whole or any part of such accumulated income in any subsequent year as if it were income of the Fund arising in the then current year.
- 6. The University shall have power to pay out of the capital or the income of the Fund all costs of and incidental to the creation of the Fund, and the management and administration of the Fund and the Scholarship.
- 7. The University may exercise any of its corporate powers in the management and administration of the Fund in so far as those powers are not inconsistent with these regulations.
- 8. These regulations shall be deemed to be Trust Regulations under the provisions of Part D of Statute XVI.

9. Subject to regulation 10, Council may amend, repeal or add to these regulations in accordance with Part D of Statute XVI, but no amendment is valid if it would cause the Fund to:

- (1) cease to be exclusively charitable according to the law of England and Wales; or
- (2) be outside the objects of the University.

10. Any amendment to regulation 3 is an amendment to the main objects of the Fund for the purposes of Part D of Statute XVI and must be approved both by Congregation of the University and subsequently by Her Majesty in Council.'

# **Conferment of Honorary Degree**

The degree of Master of Arts, honoris causa, approved by resolution of Congregation on 19 October 2021, was conferred upon Maurice Keeble-Smith.

# Paraphrase

See here a man who has known two great worlds - those of the countryside and the intricate devices of engineering. For forty years and more he served this University and its inventive researchers, teachers and students. Expert he is, a skilled machinist and welder, but well known also for those more intangible gifts of personality - wisdom, tact, and understanding of the greater limitations in our practical abilities, in which his forbearance and guidance have set so many on a more secure path to success. Here is a mind and a hand that can plan and design even when drawings cannot be made and used; here is one that can mend as well as create, can patiently teach, reassure, and make of the almost insurmountable difficulty but a minor molehill. I believe that his memory will live long in the designs of a Kawasaki motorbike and a Smart Car engine, yet in his retirement he will surely continue in that more independent movement in which he also excels - that of the bicycle, once he has strategically parked his motorhome. In the workshop you may see a safety notice above our honorand's name, telling us that 'anybody inappropriately dressed will be turned away!!!' Here, accordingly, stands that man most appropriately dressed for the occasion, for

I present an admired artist among craftsmen, a supportive guide and teacher, a dependable human being we proudly believe is to be only the thirteenth such honorand in over twenty years, Maurice Keeble-Smith, to be admitted to the honorary degree of Master of Arts.
