Council has made the following changes in regulations, to come into effect on **19 July**.

#### (a) Income grants from the College Contributions Fund: 2013 application round

### Explanatory Note

This regulation authorises the income grants which Council has decided to make from the Oxford College Contributions Fund, on the recommendations of the College Contributions Committee following that committee's consideration of new applications submitted in 2013.

### Text of Regulations

The following amounts shall be paid as income grants to the college named, in each case under the provisions of section 5 of Statute XV (approved with effect from 8 April 2009, *Gazette* of 23 April 2009, p932) for application in the financial year shown:

#### (b) Income grants from the College Contributions Fund: reconsideration of an application submitted in 2012

### Explanatory Note

This regulation authorises the income grants which Council has decided to make

from the Oxford College Contributions Fund, on the recommendations of the College Contributions Committee following reconsideration of an application submitted in 2012.

### Text of Regulations

A sum of £360,000 shall be paid in 2013-14 as an income grant to Worcester College under the provisions of section 5 of Statute XV (approved with effect from 8 April 2009, *Gazette* of 23 April 2009, p932). The grant is provided for the following purposes:

(i) for maintenance and refurbishment expenditure, a sum of £320,000 (of which £20,000 is to be used as a contribution to the cost of employing an Assistant Bursar); and

(ii) for development office expenditure, a sum of £40,000.

The sums listed are maxima. The payment of this grant, and the precise sum payable, shall be dependent on the success with which the college meets certain conditions laid down by Council on the recommendation of the College Contributions Committee. Part (i) of this grant shall be paid in tranches.

## General Purposes Committee of Council

### Changes in Regulations

The General Purposes Committee of Council has made the following changes in regulations, to come into effect on **19 July**.

#### Parsons Fund

##### *Explanatory Note*

These changes reconstitute the board of management of the fund in order to address obsolete references in the Trust Regulation.

##### *Text of Regulations*

In Part 2 of Council Regulations 25 of 2002, concerning trusts, in § 272 amend regulation 2 as follows (new text underlined, deleted text scored through):

'2. The administration of the fund, and the application of its income, shall be the responsibility of a board of management comprising: ~~The fund shall be administered, under the Life and Environmental Sciences Board, by a board of management consisting of:~~

(1) ~~the Head of the Life and Environmental Sciences Division or his or her deputy, who shall be chairman a person appointed by the General Purposes Committee of Council, who shall be the Chair;~~

(2), (3) ~~a member of the Faculty of Biological Sciences appointed by the Life and Environmental Sciences Board two persons appointed by the Mathematical, Physical and Life Sciences Board;~~

(4), (5) ~~(3) a member of the Faculty of Physical Sciences appointed by the Mathematical and Physical Sciences Board two persons appointed by the Medical Sciences Board.~~

(4), (5) ~~up to two additional members co-opted by the board of management by virtue of their experience, either in the application of physical sciences to biological and medical research, or in the development of technique.'~~

## Planning and Resource Allocation Committee of Council

### Changes in Regulations

The Planning and Resource Allocation Committee of Council has made the following changes in regulations, to come into effect on **19 July**.

#### (a) Allen & Overy Professorship of Corporate Law

##### *Explanatory Note*

The following changes amend the regulations for the Allen & Overy Professorship of Corporate Law to remove the obligation to consult with the Allen & Overy Foundation in the appointment of one of the Council electors, in accordance with the most recent Memorandum of Agreement between the University and Allen & Overy LLP. The opportunity is also taken to remove outdated references.

##### *Text of Regulations*

In Sect III of Council Regulations 24 of 2002, concerning individual professorships, delete § 176 and substitute (new text underlined, deleted text struck through):

'**§176.** Allen & Overy Professor of Corporate Law

1. The University accepts with gratitude the moneys offered by Allen & Overy LLP for the provision of an Allen & Overy Professorship of Corporate Law.
2. The Allen & Overy Professor of Corporate Law shall lecture and give instruction in Corporate Law.
3. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the head of the college specified in (2) of this clause is Vice-Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;

(2) the head of the college to which the professorship shall be allocated by Council under any regulation ~~deeree~~ in that behalf, or, if the head is unable or unwilling to act, a person appointed by the governing body of the college on the occurrence of a vacancy to act as an elector on that occasion;

(3) a person appointed by the governing body of the college specified in (2) of this clause;

(4), (5) two persons appointed by Council, ~~one of whom shall be appointed after consultation with the Allen & Overy Foundation;~~

(6) a person appointed by the Social Sciences Board; and

(7)-(9) three persons appointed by the Board of the Faculty of Law.

4. The professor shall be subject to the General Provisions of the decreeregulations concerning the duties of professors and to those Particular Provisions of the same

decreeregulations which are applicable to this chair.'

#### (b) Al Saud Professor for the Study of the Contemporary Arab World

##### *Explanatory Note*

The following change amends the composition of the electoral board of the Khalid bin Abdullah Al Saud Professorship for the Study of the Contemporary Arab World to comply with the general provisions for electoral boards laid down in Council Regulations 3 of 2004. It also replaces reference to 'decrees' with reference to 'regulations' and removes reference to the General Board.

##### *Text of Regulations*

In Sect III of Council Regulations 24 of 2002, concerning individual professorships, delete § 12 and substitute (new text underlined, deleted text scored through):

'**§12.** Al Saud Professor for the Study of the Contemporary Arab World

1. The Khalid bin Abdullah Al Saud Professor for the Study of the Contemporary Arab World shall lecture and give instruction in one or more aspects of the politics, international relations, economics, sociology, or recent history of the contemporary Arab world.
2. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor, or, if the President of Magdalen College is Vice-Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;

(2) the President of Magdalen College, or, if the President is unable or unwilling to act, a person appointed by the Governing Body of Magdalen College on the occurrence of a vacancy to act as an elector on that occasion;

(3) a person appointed by the Governing Body of Magdalen College;

(4) a person appointed by Council, in consultation with the Board of the Faculty of Oriental Studies;

(5), (6) two persons appointed by the General Board, ~~one of whom shall be appointed after consultation with the Committee for Modern Middle Eastern Studies;~~

(7) a person appointed by the Board of the Faculty of Social Studies;

(8) a person appointed by the Board of the Faculty of Anthropology and Geography;

(5) a person appointed by Council, in consultation with the Social Sciences Board;

(6) the Head of the Humanities Division, or his or her nominee;

(9)(7), (8) two persons a person appointed by the Board of the Faculty of Oriental Studies;:

(9) a person appointed by the Social Sciences Board.

3. The professor shall be subject to the General Provisions of the regulations decree concerning the duties of the professors and to those Particular Provisions of the same regulations decree which are applicable to this chair professorship.

4. Any part of the income of the endowment of the professorship which is not required to meet the costs thereof may be expended, under conditions to be determined from time to time by the General Board, on the provision of grants to the professor for travelling and other expenses incurred in the pursuance of his or her studies.'

#### Planning and Resource Allocation and Education Committees

##### (a) CLARIFICATION OF FEE LIABILITY FOR GRADUATE STUDENTS

###### *Explanatory Note*

The following changes clarify fee liability for graduate students in a number of areas, that is in relation to postgraduate taught students who are still receiving tuition or supervision after attempting an examination; students who wish to count composition fees paid while working for other graduate degrees towards DPhil fee liability, or to count fees paid towards a DPhil towards another research degree; and part-time graduate students. The changes codify existing practice in all cases. The opportunity is taken to delete an outdated clause, and to update the list of qualifications concerned. New text is underlined, and deleted text struck through.

###### *Text of Regulations*

#### With immediate effect

**1** In *Examination Regulations* 2012, p1103, delete ll 19–23, and substitute:

‘Candidates who continue to work for one of the qualifications listed above after ~~attempting failing~~ an examination shall pay a composition fee for each term in which they receive tuition or supervision; but if they receive no further tuition or supervision, they shall...’

**2** *Ibid*, delete ll 33–41 and substitute:

‘4. The number of composition fees payable under cl 3 above by those working for the degree of D.Phil. shall not exceed nine provided that:

- (a) **[for candidates admitted to graduate research study before 1 September 2006]** candidates for the D.Phil. may count towards this figure up to six composition fees paid while working for any one of the degrees of M.St., M.Sc. by Coursework, M.Phil., M.Th., M.F.A., M.Juris., B.Phil., or BCL; **[for candidates admitted from 1 September 2006 onwards]** candidates for the DPhil may count towards this figure up to three composition fees paid while working for the degree of M.Phil., M.St. in Legal Research, or B.Phil. provided that the candidate has been given leave to supplicate for that degree.]’

**3** *Ibid*, p1104, delete ll 18–34 and substitute:

‘5. Fee requirements relating to full-time students undertaking graduate study shall also apply to part-time students holding the same status, save that part-time students shall be required to pay half the applicable full-time fee over twice the applicable length of time for full-time students, except where the fee for the part-time programme is otherwise specified in the regulations, and except where the applicable period is otherwise specified under cl 6 below.

**56.** The number of composition fees payable under cl 3 above by those working for any qualification other than the degree of DPhil shall not exceed six in respect of each qualification<sup>footnote</sup>, save that those students receiving tuition or supervision after ~~attempting failing~~ an examination shall continue to pay composition fees for each term in which they receive tuition or supervision, and:

- (a) those who are part-time Students for the Degree of Master of Science in Applied Social Studies or Education shall pay not more than twelve composition fees;
- (b) those who are students for the Degree of Master of Science in Bioinformatics or Evidence-Based Health Care, or Experimental Therapeutics, or Software and System Security, or Software Engineering, Surgical Science and Practice, or Sustainable Urban Development shall pay not more and not fewer than six termly programme composition fees (at the half rate) irrespective of the period for which they are registered for that degree; and

(c) those who are students for the Degree of Master of Theology shall not pay more than six fees (at the half rate) while working for Part II of that degree; and

(d) students studying for the Degree of Master of Studies in International Human Rights Law shall pay not more than six composition fees, save that for those students under (a)–(d) above who receive receiving tuition or supervision after failing attempting an examination or who require those students requiring an extension of time shall continue to pay composition fees for each term in which they receive tuition or supervision.

Footnote: Candidates who transfer from the D.Phil. to the M.Litt. or M.Sc. by Research may count up to six composition fees paid while working towards the D.Phil. (including fees paid while holding the status Probationer Research Student) towards this figure.

**(b) FEES PAYABLE FOR EXAMINATION REGISTRATION, RE-ENTRY, RE-SUBMISSION AND LEAVE TO SUPPLICATE 2013/14**

*Explanatory Note*

The following changes amend the regulations governing the fees payable for examination registration, re-entry, re-submission and leave to supplicate in order to update these for 2013/14. Most of the fees have been uplifted in line with the increase in tuition fees for the year in question. The

fees payable for re-entry to graduate taught examinations, and for resubmission of theses for graduate research degrees, have been adjusted in the light of the associated cost of payments to examiners, and of fees charged by other comparable higher education institutions for these purposes. On this basis, fees payable for re-entry to graduate taught examinations are being reduced, while fees for resubmission of theses for graduate research degrees are being increased on a phased basis over the next three years. The revised text reorders the clauses so as more clearly to distinguish between taught awards, research awards and higher degrees. It also moves fees for late entry and change of options into the same section so that all examination-related fees are presented in one place. New text is underlined, and deleted text struck through.
