# Council and Main Committees

## General Purposes Committee of Council

The General Purposes Committee of Council has made the following changes to regulations, to come into effect on **20 February**, unless notice of a resolution calling

### (a) Professorship of Bioinformatics

#### *Explanatory Note*

These proposed changes are to clarify the role and update the membership of the electoral board, and to replace outdated references. Numbers are also being written as numerals rather than words, in line with Oxford style guidance.

#### *Text of Regulations*

In [Council Regulations 24 of 2002](#), concerning individual professorships, amend the Professorship of Bioinformatics as follows (new text underlined, deleted text struck through):

#### **‘Professor of Bioinformatics**

1. The Professor of Bioinformatics shall undertake research in and shall lecture and give instruction in Bioinformatics and generally promote its study in the University.

2. The professor shall be elected by an electoral board consisting of:

- (1) the Vice-Chancellor; ~~or, if the head of the college specified in (2) of this clause is Vice-Chancellor, a person appointed by Council on the occurrence of a vacancy to act as an elector on that occasion;~~

### (b) Professorship of Women’s Mental Health

#### *Explanatory Note*

The Medical Sciences Division, the Department of Psychiatry and the Nuffield Department of Women’s and Reproductive Health wish to establish the Professorship of Women’s Mental Health. The departments’ vision is to establish the Oxford Centre for Women’s Mental Health, which will be jointly led by the departments. The director of the centre will be the Professor of Women’s Mental Health.

#### *Text of Regulations*

In [Council Regulations 24 of 2002](#), concerning individual professorships, insert:

upon Council to annul or amend the regulation is received by the Registrar by **noon on 16 February** (as set out in [Statute VI: Council](#)).

(2) the head of the college to which the professorship shall be for the time being allocated by Council under any ~~decree~~regulation in that behalf, or, if the head is unable or unwilling to act, a person appointed by the governing body of the college on the occurrence of a vacancy to act as an elector on that occasion;

(3) a person appointed by the governing body of the college specified in (2) of this ~~clause~~regulation;

(4), (5) ~~two~~2 persons appointed by Council;

(6), ~~(7)~~ ~~(8)~~ ~~two~~3 persons appointed by the Mathematical, ~~and~~ Physical, and Life Sciences Board;

~~(8) a person appointed by the Life and Environmental Sciences Board;~~

(9) a person appointed by the Medical Sciences Board.

3. The professor shall be subject to the General Provisions of the ~~decree~~regulations concerning the duties of professors and to those Particular Provisions of the same ~~decree~~regulations which are applicable to this chair.’

#### **‘Professorship of Women’s Mental Health**

1. The Professor of Women’s Mental Health shall engage in advanced study and research and shall lecture and give instruction in Women’s Mental Health.

2. The professor shall be elected by an electoral board consisting of:

(1) the Vice-Chancellor;

(2) the head of the college to which the Chair may be allocated by Council from time to time; or, if the head is unable or unwilling to act, a person appointed by the governing body of that college;

(3) A person appointed by the governing body of the college specified in clause (2);

(4), (5) 2 persons appointed by Council;

(6)–(9) 4 persons appointed by the Medical Sciences Board;

(10) 1 person appointed by the body or bodies which may issue an honorary clinical contract or contracts to the professor.

3. The professor shall be subject to the General Provisions of the regulations concerning the duties of professors and to those Particular Provisions of the same regulations which are applicable to this chair.’

### (c) Lombard Odier Sustainable Finance Fund and Lombard Odier Associate Professor and Senior Research Fellow of Sustainable Finance

#### *Explanatory Note*

The following changes have been made in response to a request from the donor whose gift established this fund.

#### *Text of Regulations*

In [Council Regulations 25 of 2002](#), concerning the Lombard Odier Sustainable Finance Fund, amend as follows (new text underlined, deleted text struck through):

#### **‘~~Lombard Odier Sustainable Finance Fund and Lombard Odier Associate Professor and Senior Research Fellow of Sustainable Finance~~**

1. The University receives with gratitude a gift from Swiss Friends of Oxford University (“SFOU”) and originating from Bank Lombard Odier & Co Ltd (the “Ultimate Benefactor”) to be held as an expendable endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so

held shall be known as the ~~Lombard Odier~~ Sustainable Finance Fund (“the Fund”).

2. The post maintained by the Fund (“the Post”) shall be known as the ~~Lombard Odier~~ Associate Professor and Senior Research Fellow of Sustainable Finance upon the appointment of the first holder of the Post (the “First Postholder”). Upon the appointment of the successor to the First Postholder, the Post shall be known as the ~~Lombard Odier~~ Associate Professor or ~~Lombard Odier~~ Professor of Sustainable Finance at the University’s discretion. Any appointment panel convened for the purpose of appointing the successor to the First Postholder shall be at the University’s sole discretion. If the panel convened for this purpose includes an external member, such member shall be appointed by the University after consultation with SFOU provided that such external member shall not be: (1) an employee of the University; (2) an officer or delegate of SFOU; or (3) a director, employee or representative of the Ultimate Benefactor or another entity in the Ultimate Benefactor’s group.’

### (d) Insight Investment Fund

#### *Explanatory Note*

The following changes have been made in response to a request from the donor whose gift established this fund, and to reflect changes to the Sustainable Finance Fund trust regulation. The opportunity is also being taken to make clear that the gift is permanent endowment.

#### *Text of Regulations*

In [Council Regulations 25 of 2002](#), concerning the Insight Investment Fund, amend as follows (new text underlined, deleted text struck through):

#### **‘Greening Finance Prize~~Insight Investment~~ Fund**

1. The University receives with gratitude gifts to be held as permanent~~an~~ endowment on the trusts declared in this regulation. Further money or property may be paid or transferred to the University as either expendable or permanent endowment to be held on the same trusts. The assets so held will be known as the Greening Finance Prize~~Insight Investment~~ Fund (“the Fund”).

2. The University shall retain as permanent endowment those of the assets in the Fund which are contributed on the express understanding that they are to be treated as permanent endowment (“the Permanent Endowment”).

3. The University shall (a) apply the income of the Permanent Endowment; and (b) apply the income and, in its discretion, the capital of the remainder of the Fund, towards the provision of prizes to recognise outstanding research and service in support of the furtherance of greening finance (“the Prizes”).

4. The selection of Prize winners in each year shall be the responsibility of a prize panel (“the Prize Panel”) nominated by the holder of the post maintained by the ~~Lombard Odier~~ Sustainable Finance Fund (“the Post”), from time to time, and subject to the approval of the Head of the School of Geography and the Environment. If the Post is vacant or the University ceases to appoint to the Post for any reason, the selection of candidates for the Prizes shall be the responsibility of the Head of the School of Geography and the Environment.’

## Congregation 10 February

### Voting on a Resolution authorising the allocation of space called the Garden Land to Kellogg College

#### NOTICE OF OPPOSITION

1) The explanatory note makes clear that the proposed “Garden Land” allocation is not a routine administrative allocation of amenity land. It expressly permits the construction of three newbuild graduate accommodation blocks, together with associated landscaping works, and further allocates additional land temporarily for contractor use and construction activity. This is a fundamental shift from the prior position explicitly set out in earlier allocations, under which the rear gardens associated with 2–6 Winchester Road and 47–55 Banbury Road were allocated solely as amenity land, subject to formal take-back provisions, and with a proviso that no development could be undertaken in the gardens. The present resolution reverses that

settled position by authorising, for the first time, the construction of three new-build accommodation blocks on that land. It therefore represents a major change, not a routine or technical reallocation, and should not proceed via an expedited “deemed approved” route without robust and transparent scrutiny by Congregation.

2) Congregation is being asked to approve a large space allocation (per the Statute XVI explanatory note) that is explicitly tied to construction of three new buildings. However, members are not provided (within the resolution papers themselves) with the information needed to assess impacts, including: outline design parameters; construction duration and phasing; access routes, contractor logistics, traffic impacts, and storage and laydown areas; noise, vibration, dust, and working-hours assumptions; tree and biodiversity impacts in the rear gardens; how impacts will be managed while SAME remains an occupied workplace at 43 and 51–53 Banbury Road (with occupation stated to continue until the development of 25 Wellington Square completes, estimated 2029 at the very earliest); governance and accountability for mitigation, and what recourse exists if commitments are not met. In effect, Congregation is being asked to authorise an allocation that enables construction while being denied the core evidence required to evaluate consequences for staff, students, and neighbouring University activities.

3) The explanatory note explicitly states that 51–53 Banbury Road has been allocated in principle to Kellogg

but remain occupied by SAME until at least 2029. The same note then proposes a “Garden Land” allocation that (a) withdraws the rear gardens of 51–53 from functional use and (b) permits construction of three new-build blocks. Major construction in this backland will predictably impose multi-year impacts on SAME’s core functions, including teaching, research, supervision, meetings, public events, and day-to-day scholarly work. SAME staff and students face the prospect of working for months and even years in a construction zone, which raises issues of welfare, accessibility, safety, noise and air pollution, and disruptions to the normal use of an

academic setting. It places an unacceptable burden on a department that has already been told it may remain in situ until 2029 or later.

4) Given SAME’s continued occupancy of 43 Banbury Road and 51–53 Banbury Road, it is indefensible to proceed without demonstrated, meaningful consultation with the staff and students who will bear the consequences. The explanatory note does not evidence such consultation, nor does it describe binding protections, compensation, or operational guarantees.

### General requirements and eligibility

All candidates are asked to note the general requirements which apply to all committee members, as set out in [Council Regulations 14 of 2002 \(General Regulations of Council for Committees\)](#). Current members seeking re-election are also asked to check for specific restrictions on consecutive service. For further information, please see the [eligibility](#) and [amendments to nominations](#) sections within the [Information about University elections pages](#) of the [Elections](#) website.

### Candidates' statements

Candidates are invited to include with their nomination forms a written statement of no more than 250 words, setting out their reasons for standing and qualifications for the office being sought.

### Contested elections

In the event of a contested election, the successful candidates will be determined by an electronic ballot. An email with further instructions will be sent to eligible voters on Wednesday, 18 February, using the email addresses provided in the electronic register of

Congregation (NB with few exceptions, notably clinical staff, this will be the work address ending 'ox.ac.uk'). Candidates' statements will be published online and in the *Gazette* dated Thursday, 19 February. Voters may wish to read these statements before completing their electronic vote. The voting period will close at 4pm on Thursday, 5 February 2026.

### Uncontested elections

If the number of nominations received by the closing date is no more than sufficient to fill the vacancies, the candidates nominated shall be deemed to be duly elected as of the close of the nomination period on Thursday, 5 February. When required, places will be allocated according to academic standing, as defined in [Council Regulations 22 of 2002, Part 2: Academic Precedence and Standing](#). If the number of nominations received by the closing date is less than sufficient to fill the vacancies, those candidates nominated will be deemed elected unopposed, and the remaining vacancies will lapse, in which case, in accordance with the regulations, the places must remain vacant until appointments are made jointly by the Vice-Chancellor and Proctors.

### Period of office

In accordance with [Congregation Regulations 2 of 2002](#), in any election where vacancies are to be filled for periods of different length, the elected candidates shall hold office so that the tenure of those who receive more votes shall be longer than that of those who receive fewer votes; but if the election is uncontested or if two candidates receive the same number of votes, the candidate senior in academic standing shall hold office for the longer period.
