Council of the University

Council has made the following changes to regulations, to come into effect on **22 November**, unless notice of a resolution calling upon Council to annul or amend

(a) Education Committee

Explanatory Note

The following change to the membership has been made to align with the Standing Orders for Conference of Colleges and to enable increased flexibility for Conference of Colleges to appoint a representative with sufficient expertise and seniority. The following change to the responsibilities of the committee has been made to provide greater clarity of the committee's role in undergraduate admissions under the Common Framework for Undergraduate Admissions.

Text of Regulations

In [Part 2 of Council Regulations 15 of 2002](#), concerning Education Committee, amend as follows:

(b) Student Life Subcommittee

Explanatory Note

The following changes to the membership have been made to provide for greater operational expertise in matters relevant to the subcommittee's work.

Text of Regulation

In [Part 38 of Council Regulations 15 of 2002](#), concerning Student Life Subcommittee of the Education Committee, amend as follows:

(c) Oxford Green Estate Stewards Subgroup

Explanatory Note

The Oxford Green Estate Stewards Subgroup will be a subgroup of the Buildings and Estates Subcommittee with the aim of overseeing the use and management of a strategic grouping of land assets to be termed the Oxford Green Estate.

Text of Regulations

In [Council Regulations 15 of 2002](#), concerning Committees Reporting Directly to Council or one of its Main Committees, insert:

'Oxford Green Estate Stewards Subgroup

1.1 The Oxford Green Estate Stewards Subgroup shall consist of:

'Education Committee

2.1 The Education Committee shall consist of: [...]

(9) the Chair or ~~Vice-Deputy~~ Chair [or their Head of House nominee](#) of the Conference of Colleges; [...]

2.2. The committee may co-opt up to three additional members, two of whom may be external members. [...]

(2) defining and keeping under review in the context of the University's Strategic Plan the educational philosophy, policy, and standards of the collegiate University including:

(a) undergraduate and graduate admissions [including fulfilling the committee's obligations under the Common Framework for Undergraduate Admissions](#);

'Student Life Subcommittee

38.1 The Student Life Subcommittee of Education Committee shall consist of: [...]

(5) a ~~Tutor for Graduates~~ [Domestic Bursar](#) elected by the Conference of Colleges;

(1) A Chair, who shall be a member of Congregation appointed by the Vice-Chancellor;

(2) the Director of Estates or nominee;

(3) a member of the Buildings and Estates Subcommittee nominated by its Chair;

(4) a member of the Environmental Sustainability Subcommittee nominated by its Chair;

(5) the Head of Gardens, Libraries and Museums or nominee;

(6) the Director of the Department for Continuing Education or nominee;

(7) the Pro-Vice-Chancellor (Research) or nominee;

(8) a representative of the colleges, elected by Conference of Colleges.

1.2 The group may co-opt up to three additional members, who may be external.

1.3 The Oxford Green Estate Stewards Subgroup shall be responsible to the Buildings and Estates Subcommittee.

(1) The Oxford Green Estate is comprised of land, woodland and waterways along with associated residential and commercial properties held by the University, utilised for the purposes of research, education and outreach and to support the University's Environmental Sustainability Strategy.

(2) The subgroup shall oversee the management of the Oxford Green Estate.

(3) In particular the subgroup shall:

(i) prioritise and sequence the varying demands for use of the Oxford Green Estate;

(ii) deliver a coordinated and consistent approach to planning for Oxford Green Estate assets;

(iii) embed best practice into the operation and management of the Oxford Green Estate and promote this approach within the wider University and partnership organisations;

(iv) ensure visibility of academic opportunities within the Oxford Green Estate;

(v) monitor and put in place procedures to manage access to the Oxford Green Estate by members of the University and the general public;

(vi) supervise the management of resources within the Oxford Green Estate, including;

a. making proposals to the Buildings and Estates Subcommittee for recommendation to Planning and Resource Allocation Committee on the annual budget of the Oxford Green Estate;

b. Consider and make proposals to the Planning and Resource Allocation Committee (through the Buildings and Estates Subcommittee) on the acquisition, leasing and disposal of land and property within the Oxford Green Estate;

(vii) oversee the provision of community outreach and engagement activities related to the Oxford Green Estate;

(viii) maintain constructive relationships with other landowners and stakeholders in order to further the strategic objectives of the Oxford Green Estate; and

(ix) embed the tenets of wellbeing, education and creativity within policy development across the Oxford Green Estate.

1.4 The subgroup shall serve as the board of management of University trusts connected with the Oxford Green Estate, namely:

(1) The University of Oxford ffennell Fund;

(2) Godstow Nunnery;

(3) Mrs D M Gladman Bequest;

(4) Wytham Village Fund.'

Ethical Investment Review

The University has launched a review of its ethical investment approach, following concerns raised by members of the community.

The University is committed to ensuring its endowment is managed sustainably and with integrity, to benefit both current beneficiaries and future generations. Its approach in this area is led by the University's Investment Committee with advice from the [Ethical Investment Representations Review Subcommittee](#) (EIRRS), which includes academic and student representatives.

Council has asked EIRRS to lead an accelerated University wide review of the current prohibition on direct investments in companies manufacturing arms that are illegal under UK law (introduced in 2010) as well as investment in funds which invest primarily in such companies (introduced in 2021), and to discuss this restriction's continued appropriateness or whether it should be extended.

EIRRS will seek expertise and evidence from various representative groups across the University to hear diverse student and staff voices, including but not limited to: Education Committee, Research and Innovation Committee, Committee to Review Donations and Research Funding, Divisional Boards, major beneficiary trusts of the University endowment, Conference of Colleges and OU Endowment Management, as well as reviewing approaches of similar institutions globally. EIRRS will report its findings regarding the University Investment Policy Statement to Investment Committee, prior to further consideration by Council.

Call for nominations for Honorary Degrees and for Degrees by Diploma

The Committee on Honorary Degrees is seeking honorary degree nominations. Nominations can be made by current members of staff and students via the online form: <https://forms.office.com/e/u1kmkyKYmR>.

When considering possible honorands, the Honorary Degrees Committee will focus on individuals:

- of high academic distinction in the fields of research and scholarship of specific interest to the University of Oxford;
- distinguished in the visual, literary, musical, and performing arts or in sports;
- distinguished in business and industry;
- who have played a distinguished role in public life, for example in contributing to progress and change in society;
- who have made a significant contribution to the activities of the University of Oxford—such individuals would normally also fall into one of the categories above.

Within those categories, the Honorary Degrees Committee will aim to produce a balanced list, which takes account of the global dimension that characterises this University's activities.

When a degree is conferred upon a royal personage or upon the head of a foreign state it will be conferred by diploma.

Two webinars will take place in November as part of the review, providing all staff and students with an opportunity to find out more about the University's investments and the review, and to ask questions. Groups and individuals can also provide submissions direct to the review.

In Hilary term 2025, EIRRS will provide its report with findings and any arising recommendations which might propose amendments to the University's Investment Policy Statement to Investment Committee, prior to any decision at Council. More information will follow at that point.

The Honorary Degrees Committee has adopted a target that half of the final list of names proposed for the conferment of honorary degrees be women and/or from minoritised groups. Nominators are therefore encouraged to propose individuals of conspicuous distinction with particular reference to diversity.

Honorary degrees will not be conferred on anyone who holds, or who has retired from, a resident teaching, research or administrative post within the University or in any college or other society, except in exceptional circumstances such as distinguished service outside the terms of his or her paid service. In these circumstances, a proposal for an honorary MA may be put forward.

While informal soundings within the University will often be desirable, every effort should be made to ensure that publicity is not at any stage given to any specific proposal for the conferral of an honorary degree. All nominations will be considered in strict confidence by the committee.

While nominations may be submitted throughout the year, the deadlines for nominations for Encaenia 2026 are **6 January 2025** and **10 April 2025**. Nominations are kept under consideration by the committee for 3 years (the year of nomination, plus 2 years) so only need to be resubmitted if there has been a significant change in the case for the nomination.

VOTING ARRANGEMENTS

A first round of voting took place at a Convocation in the week commencing 28 October for the purpose of electing a Chancellor.

As outlined on the Chancellor's election webpage (www.ox.ac.uk/about/organisation/university-officers/chancellor/chancellor-election), this election uses the Alternative Vote system, whereby voters can rank as many of the candidates as they choose. Lower-ranking candidates have now been eliminated; 5 candidates remain. These 5 candidates (listed below in alphabetical order) are going forward to a second round, to take place during Week 6 of Michaelmas term (week commencing 18 November). The first candidate to achieve 50% of the vote following the second round will be elected Chancellor.

THE CHANCELLORSHIP

Statutory provision

[Statute IX, sections 2–5](#), provides as follows.

‘2. The Chancellor shall be elected by Convocation and shall hold office for a fixed period decided by Council or until their resignation.

The election is taking place online only and is administered by Civica. The election is conducted in accordance with the provisions of Council Regulations 8 of 2002 (*Gazette No 5421, pp440–1*); these regulations are available on the University website at: <https://governance.admin.ox.ac.uk/legislation/council-regulations-8-of-2002>. Registered voters will receive an email directly from Civica with a link to cast their vote for the second round.

The new Chancellor will be announced during Week 7 (week commencing 25 November).

3. There shall be a Chancellor's Court of Benefactors to membership of which the Chancellor may from time to time admit major benefactors of the University.

4. The Chancellor shall have such other functions and powers as are assigned to them by the statutes and regulations or by the law of the land.

5. In the event of the incapacity or absence abroad of the Chancellor; or during a vacancy in the Chancellorship, or on delegation from the Chancellor, the Vice-Chancellor

may exercise any of the functions and powers of the Chancellor, except where the statutes provide otherwise.’

STATEMENT ON THE CHARACTERISTICS OF A CHANCELLOR

For the guidance of candidates and electors

The Chancellor is the ceremonial head of the University of Oxford. While this key role has no executive responsibilities, it is more than symbolic; the Chancellor provides supportive and useful advice and guidance to the University, particularly to the Vice-Chancellor. The Chancellor presides at events such as Encaenia and at the Chancellor’s Court of Benefactors and is sometimes expected to take a leading role at other official events. The Chancellor is the Visitor (an external figure of authority on whom the college can call for advice and for arbitration if insoluble dispute arises among its governing body) of five colleges and also chairs the Committee for the Nomination of the Vice-Chancellor. In addition to these formal duties, the Chancellor undertakes advocacy, advisory and fundraising work, acting as an ambassador for the University at a range of local, national and international events. The Chancellor

must be readily accessible and available throughout the year.

The University is seeking a candidate who can demonstrate:

1. outstanding achievements in their field and the ability to command respect beyond it;
2. a deep appreciation for the University’s research and academic mission, its global community, and its ambition to remain a world-class research and teaching university;
3. the ability and willingness to enhance the reputation of the University locally, nationally and abroad.

CANDIDATE LIST

Following elimination of lower-ranking candidates during the first round of voting, 5 candidates go forward to a second round of voting.

Candidates have been considered by the Chancellor’s Election Committee solely against the specific exclusion criteria as laid out in [Part 7 of Council Regulations 8 of 2002](#), with no subjective selection process.
