Each of papers II, to IX will be assessed by a written examination.

Candidates will offer papers II, III, VI-IX at either intermediate or advanced level as appropriate to their level of study. Details of syllabuses, prescribed texts and editions for all papers will be published in the course handbook.

Any candidate whose first language is not English may bring a bilingual (first language to English) dictionary for use in any examination paper where candidates are required to translate Ancient Greek and/or Latin texts into English and any examination paper involving Greek or Latin prose composition.

Candidates offering both Greek and Latin who fail between one and four papers may resit only the relevant failed paper(s) at a subsequent examination. Candidates who fail five or more papers will be required to resit the entire examination.

Candidates offering only one of Greek or Latin who fail between one and three papers may resit only the relevant failed paper(s) at a subsequent examination. Candidates who fail four or more papers will be required to resit the entire examination.

The word limit includes all footnotes, intext references, and appendices, but excludes the bibliography, the title, the statements of word count, school and candidate number, and any mathematical expressions and code. Translations of foreign language quotations should be included alongside the original quotation but only the original will count towards the word count. Images may be included in an essay, but any text contained in the images will normally be included in the word count. All other elements, unless specified otherwise, will be included in the final word count.

Explanatory Notes

The Faculty of Philosophy would like to make a number of small changes to these regulations. It is intended that these changes will provide more certainty for candidates as to what is and is not included in word limits for submissions, and to provide the potential option of more than one Special Subject. These are positive changes.

The minor change at 1.102 is a tidying-up process: a previous paper was discontinued in 2014 whilst a new paper in Philosophical Logic (127) was developed and introduced: 1.102 was intended at that time as a stopgap. With paper 127 now in full effect, the temporary option is no longer needed.
